TITLE: Motion Approving a Service Agreement for Advanced Metering
Infrastructure Solution Consultant Services - Black & Veatch Corporation -
\$237,138 - (**Commission Districts 1, 2, 3 and 4**)

Recommendation

Staff recommends the City Commission approve a two-year Service Agreement in substantially the form attached, for Advanced Metering Infrastructure (AMI) Solution Consultant Services - Consultants' Competitive Negotiation Act (CCNA) with Black & Veatch Corporation in the amount of \$237,138 and authorize the City Manager to approve two (2) one-year renewal options.

Background

The City of Fort Lauderdale's Water Utility Division of the Public Works Department owns and operates approximately 64,000 potable water meters ranging from 5/8" to 16" in diameter. On an annual basis, the City bills for approximately 34 million gallons per day (MGD). In recent years, the City has experienced different challenges with its water meter infrastructure, such as inaccurate meter readings resulting in revenue loss from lost water. Furthermore, the City's current meter infrastructure uses mechanical moving parts whose accuracy is known to decrease over time resulting in water loss, inconsistency in water billing, and neighbor dissatisfaction.

On February 22, 2022, the Procurement Services Division issued Request for Qualifications (RFQ) 12648-1026 - Advanced Metering Infrastructure (AMI) Consultant Services. A total of nine (9) firms submitted proposals for consulting services.

1. Arcadis U.S., Inc.
2. Atlas Design Services, LLC
3. Black & Veatch Corporation
4. EMA, Inc.
5. E Source Companies, LLC
6. GHD Services, Inc.
7. Jacobs Engineering Group Inc.
8. Quanta Technology, LLC
9. Shpigler Consulting Inc

None of the nine (9) firms listed their status as a Disadvantaged Business Enterprise (DBE).

On April 8, 2022, the Evaluation Committee convened and shortlisted the top three (3) highest-ranked vendors:

1. Jacobs Engineering Group Inc.
2. Arcadis U.S., Inc.
3. Black & Veatch Corporation

These firms were invited to conduct vendor presentations to the Evaluation Committee (Committee) on April 14, 2022. The Committee wanted the opportunity to ask the vendors questions regarding their proposals.

Following the vendor presentations, the Committee ranked Black & Veatch Corporation as the top ranked vendor. Additionally, Black & Veatch Corporation met all the specifications of the RFQ.

Black & Veatch Corporation is being recommended for award as the consultant to help the City develop the Request for Proposal (RFP) for the AMI implementation and to act in the capacity of “owner’s representative” to ensure the City implements the AMI successfully.

This Service Agreement is for the first phase of the AMI implementation which is limited to the development of the AMI RFP and vendor selection. In the second phase, which will be negotiated separately, Black & Veatch Corporation shall act in the capacity of “Owner’s Representative” to ensure that the City implements the AMI successfully.

Resource Impact

There will be a fiscal impact to the City in the estimated amount of \$237,138 for the contract award. Funds are available for this purchase in the FY 2022 Operating Budget, as stated below. The available balance in the chart below reflects the amount remaining after the removal of the pre-encumbrance established for this purchase. Pre-encumbrance is included on RQ2203127 in the amount of \$200,000.
