I. Welcome and Introductions

Ingrid Kindbom introduced herself as Staff Liaison and noted she was filling in for Sarah Spurlock, Nighttime Economy Manager.

II. Call Meeting to Order

Ms. Kindbom called the meeting to order at 2:00 PM. Roll call was done and there was a quorum.

III. Approval of the February 28, 2022, Minutes

Motion made by Ms. Ellis, seconded by Mr. Lochrie to approve the February 28, 2022, minutes. In a voice vote, the **motion passed** unanimously.

IV. Selection of Chair for 2023

Motion made by Ms. Ellis, seconded by Mr. Hanbury to nominate Robert Lochrie as Chair. In a voice vote, the **motion passed** unanimously.

Roll was called and there was a quorum.

V. Discussion of 2022 Walk of Fame Nominations

Chair Lochrie provided background on the process and noted that they typically had a first run and then a second run to narrow down the nominees. He stated they had selected four (4) winners the last few years. He added that the public may present their nominees before the Committee discusses. He acknowledged the Committee had read all submitted materials.

Ms. Ilona M. Holmes, retired Broward County Circuit Judge and member of the NAACP, nominated Eula Johnson. She spoke on her accomplishments including attempts to integrate Fort Lauderdale beaches in the 1960s. Additionally, Ms. Johnson owned two gas stations and a grocery store.

Mr. Hanbury stated there were a lot of great candidates but recommended this nominee be selected.

MOTION made by Mr. Hanbury, seconded by Mr. Shavloske to recognize Eula Johnson as a 2023 Walk of Fame Honoree. In a voice vote, the **motion passed** unanimously.

Ms. Lisa Scott, President and CEO of Winterfest, nominated Shane Strum. She discussed his accomplishments including leadership within the community and being a member on the Winterfest Board for over 20 years. She also spoke about his work as CEO of Broward Health including vaccinations and development of a mobile medical RV.

Ms. Micki Scavone, General Manager of Carr Workplaces, also spoke in support of Mr. Strum. She shared a personal story in connection to Mr. Strum.

Ms. Renee Quinn, President and CEO of QuinnProQuo, also spoke in support of Mr. Strum.

Mr. Dennis Ulmer nominated Henry Kinney. He spoke about Mr. Kinney's accomplishments including his work on the tunnel referendum and contribution to economic growth.

Mr. Gary Chisling, Vice President of Team Horner, spoke about Dr. Bill Kent's accomplishments including his commitment to Team Horner, International Swimming Hall of Fame, scholarships, and water safety.

Mr. Grant Smith nominated Michael Egan. He spoke about Mr. Egan's accomplishments including his impact as a business owner of Alamo Rent a Car, Broward Center for Performing Arts, and donor to the Swimming Hall of Fame.

Mr. Stephen McWilliam nominated Frank Adderley. He spoke about Mr. Adderley's accomplishments and leadership within the Fort Lauderdale Police Department.

Ms. Judy Stern also spoke about Mr. Adderley's nomination and his work within the Fort Lauderdale community.

Ms. Kathy Salerno, Director of Community Affairs at Broward Health, spoke about Mr. Strum's nomination and highlighted his work to increase access to healthcare for underserved populations.

VI. 2023 Walk of Fame Selections

Committee discussed procedures for ranking. Chair Lochrie recommended ranking Top 8, with #8 being the highest choice. Chair Lochrie noted Ms. Johnson has already been selected at spot #8.

Committee discussed various nominees and their accomplishments.

Ms. Kindbom tallied the scores and noted the top four choices were: Eula Johnson, Shane Strum, Frank Adderley, and Chuck Black. Ms. Ellis noted Mr. Black was deceased and spoke about some of his accomplishments.

Chair Lochrie asked Ms. Kindbom to read the additional names, in order of descending scores.

Discussion ensued about the nominees, criteria for decision making, scoring, and whether to consider a fifth nominee.

Chair Lochrie listed their top five choices, in no order: Eula Johnson, Shane Strum, Frank Adderley, Chuck Black, and Michael Egan.

MOTION made by Mr. Hanbury, seconded by Mr. Shavloske to nominate a fifth 2023 Walk of Fame Honoree. In a voice vote, the **motion passed** unanimously.

Ms. Kindbom stated the five nominees would go to the City Commission for consideration on March 8, 2023.

For 8 years Michael Albetta has played a major role in the Annual Turkey giveaway hosted at Sanctuary Church. Annually, this event provides holiday meals to over 1,000 local families. Michael's role in planning

JW and the Arpin family have been an integral part of Lauderdale and its history since 1908. JW is the 5th generation owner/operator of the city's oldest contracting-engineering, Arpin & Sons, that specializes in historic preservation and high-end construction. Named 2023 "Top 40 under 40" by The American Woodworking Network and considered one of the foremost experts on Dade County Pine, JW is a staunch supporter of historic preservation in South Florida and a senior board member with The Broward Trust for Historic Preservation. In the upcoming 2024 year, he is slated to perform historic work on The Stranahan House and The Hillsboro Inlet Lighthouse. He is also assisting The Pompano Beach historical society with

restoration work on the remaining Kester cottages and their Dade County Pine floors. In the recent past, he has performed work on numerous historically significant homes and places such as: The Maroone's Villa Poinciana in Idlewyld, The Hollywood Women's Club, Sailboat Bend residences, Mizner and Abreu designs, and more. He is also slated to speak about Fort Lauderdale history and its relationship with Dade County Pine in the coming months. JW's reputation and work is well-known within the local historical community and with a number of the city's wealthiest and most influential residents. His clientele list is a "who's who" of Lauderdale. In addition to historic preservation and high-end contracting, JW is working with scientists from US Forestry to research and document the singularly unique traits of the rarest American Pine lumber species in existence found nowhere else outside of SFL. And his family accounts/stories about old Lauderdale are unparalleled.

In his generation, you would have an awfully hard time finding anyone in Broward with a comparable background and resume. JW's career and motivations revolve around the preservation, protection, documentation, and advocacy for Fort Lauderdale and Broward County history. His direction and efforts have been substantiated and encouraged by a nationally known local (now deceased), Randy Shropshire of Old Florida Lumber. Who labeled JW as the future of historic preservation, Dade County Pine expertise, and fine woodworking in the area. JW considers this the ultimate compliment and acknowledgment of his work moving forward.



With Kathleen at the helm, United Way of Broward County (UWBC), fights for the Health, Education, and Financial Prosperity of EVERY person in our community which has resulted in long-lasting positive change in Broward. As President/CEO of UWBC, Kathleen utilizes her talents, passion, and undeniable ability to recognize unmet needs, then seeks out partners to create long-lasting, positive solutions and financial support. She works to heighten the successful convergence of non-profits, community leaders, volunteers, and private businesses to help those most in need.

With three focus points in mind: HEALTH, EDUCATION, and FINANCIAL PROSPERITY, Kathleen has made it her mission to successfully create and manage key programs, projects, and campaigns that directly impact our community.

Health:

United Way of Broward County's Commission on Behavioral Health & Drug Prevention helps adults, children, and youth live substance-free. Through MISSION UNITED, UWBC is aligning existing services and creating solutions where there are gaps in support. To date, more than 20,000 veterans have been provided with critical resources.

The HU fund provides gap financing that lowers the cost of the development of rental or housing units. This initiative looks to generate more than 500 new affordable housing units to support the ALICE population families by 2024.

The Rick Case Automotive Group also funded the Rick Case storefronts for Junior Achievement of South Florida, an interactive exhibit at the group's JA BizTown located in Coconut Creek, Florida. The hands-on displays allow children to experience the inner workings of a car dealership.

The Community Foundation of Broward

In 2023, the Community Foundation of Broward recognized Rita and Rick as a Community Builder and celebrated the establishment of the Rita & Rick Case Family Fund during a special ceremony that included a ribbon cutting and unveiling of a plaque with the couple's portrait that now hangs on the Community Foundation's Wall of Fame. The fund fuels their lifetime commitment to philanthropy and ensures support for initiatives that have the greatest impact on children, families, education and healthcare in Broward County. Rita has been involved with the Community Foundation of Broward serving as a board member and on the strategic planning committee.

Habitat for Humanity of Broward

In conjunction with Habitat for Humanity of Broward, Rita launched the Rita Case WOMENBuild in 2023, which has raised more than \$800,000 in sponsorships for eight new homes at 'A Rick Case Habitat Community.' When complete, this Pompano Beach community of 76 homes will be the largest affordable homeownership community in the county's history. The support of Rita, the Rita Case WOMENBuild and other partners is imperative to providing homeownership opportunities to those in need. Habitat Broward's Women Build program dates back to 2002. Since then, it has engaged, equipped and empowered more than 1,000 women to fund and build 52 homes throughout Broward County. Women Build is a global movement with 1,200 affiliates that seeks to empower women to support women and families in need of affordable housing. The need for affordable housing is great in Broward. According to the Broward Housing Council, 42% of homeowners and 60% of renters in Broward County are either cost burdened or severely cost burdened, meaning the households are spending more than 30% of their monthly income on mortgage or rent. Affordable housing uplifts residents, encourages social connection, increases adjacent property values, attracts businesses, creates jobs and lowers crime rates.

Soles4Souls' 4 EveryKid

Rita and Rick got involved with Soles4Souls in 2013. They began by providing coats and shoes to children at Boys & Girls Clubs in Broward County, Florida and in Idaho.

Rita, along with Soles4Souls, has since founded the 4EveryKid program in Broward County and partnered with Broward County Public Schools (BCPS) Homeless Education Assistance Resource Team (HEART) to provide new name-brand athletic shoes to students facing housing instability. Since becoming the founding sponsor and chief fundraiser for 4EveryKid Broward in Spring 2022, Rita has raised nearly \$500,000 for the program with many five-year commitments to secure funding for years to come. To date, 3,755 Broward kids have received new athletic shoes through the initiative. According to research conducted by Soles4Souls, a new pair of athletic shoes can directly impact a child's attitude and performance in and out of school. More than 90% of kids gained confidence with new shoes on their feet, were more excited to attend school, engaged in more physical activity and felt more equal to their peers. New shoes give kids the opportunity to participate more fully in school, and it frees up resources their parents can then use for other necessities. More than 1.5 million children in the U.S. don't have stable housing, and their families lack sufficient resources to meet all their basic needs. More than 18,000 kids in southeast Florida are experiencing homelessness, with at least 7,000 of those in Broward County alone.

Pace Center for Girls

Rick Case Automotive Group has supported the Pace Center for Girls Broward for years and their mission to provide girls and young women an opportunity for a better future through education, counseling, training and advocacy. In 2021, Rita donated \$50,000 to the Pace Center for Girls "Inspiring Dreams, Changing

Lives" Capital Campaign.

Holy Cross Health

A strong supporter of initiatives that have the greatest impact on healthcare, Rita also recently made a significant donation to Holy Cross Health for areas of greatest need.

Broward Health Medical Center

Following a \$50,000 donation to Broward Health Foundation by Rita in 2022, the Rita & Rick Case Echo Lab at Broward Health Medical Center was launched. The lab features the latest echocardiography technology that creates images of the heart, blood vessels and blood flow levels that doctors use to assess heart function.

Joe DiMaggio Children's Hospital Foundation

Rick Case Hyundai Plantation and Rick Case Hyundai Davie represented all South Florida Hyundai dealerships in presenting a \$100,000 Hyundai Impact Award from Hyundai Hope On Wheels and the South Florida Hyundai Dealers Association to Joe DiMaggio Children's Hospital Foundation to help fund pediatric care and support at the hospital.

CPR Training Kits to Broward County Schools

Thanks to a generous multi-year donation from Rita to the American Heart Association (AHA), multiple Broward County Public Schools in underserved neighborhoods will continue to receive newly upgraded CPR in Schools Training Kits from the American Heart Association. The kits, which are used to facilitate adult CPR with breaths, adult hands-only CPR, child CPR, adult and child choking relief, and general AED awareness, will be used by the schools to teach lifesaving CPR skills and automated external defibrillator familiarization, as well as how to provide choking relief. According to the American Heart Association, cardiac arrest is a leading cause of death in the U.S. and approximately 90% of people who suffer out-of-hospital cardiac arrests die. CPR, especially if performed immediately, can double or triple a person's chance of survival. The American Heart Association wants all students and educators to learn CPR, putting more qualified lifesavers in local communities.

Establishment of the Rita and Rick Case Changemaker Award

In a rare move by a national organization to establish a perpetual recognition award, the American Heart Association announced the inaugural Rita and Rick Case Changemaker Award during the 2023 Heart Ball. Beginning this year, the award will be presented annually in perpetuity to someone who has made an impact, sets the tone, leads by example and inspires others to join the mission of the AHA. This is the first award of its kind in the AHA's South Florida market.

Over the past decade, Rita and Rick have dedicated their time, leadership, support and creativity to help the AHA achieve goals and take the organization to new heights. They also laid the foundation for the annual Broward Heart Walk, going above and beyond with their support. Their generosity has enabled the AHA to give the gift of time back to so many families in the community.

Contributing to the Transformation of Huizenga Park

The Rick Case Automotive Group generously donated \$150,000 to the Huizenga Park Foundation in support of the Fort Lauderdale Downtown Development Authority's (DDA) efforts to transform Huizenga Park into a welcoming open space for generations to come. A year and a half after her surgery, as she was reaching a point where the studio had grown in local and tourist recognition, she had to close the studio in 2020 for a period of 3 months due to the COVID 19 pandemic. Through that time Claudia painted murals, updated the studio's online presence, expanded her product offerings and kept the faith that she would reopen and the community would continue their support. In late 2020, the studio reopened and continues to expand art and retail sales locally and nationally. 



It initially focused on single-family homes but soon expanded to include multi-occupant residential buildings and commercial projects. During the late 1970s, Jerry found an opportunity to add airport property development to his company portfolio by executing projects at the Fort Lauderdale Executive Airport. These developments would give birth to Sheltair while also marking the start of his legacy in the general aviation industry.

As Jerry expanded the company by building and leasing aviation properties across multiple Florida airports, he gained an appreciation for the FBO business. 





Carlton B. Moore's contributions to the community began while in elementary school, where he and 7 other black students integrated Rock Island Elementary School. He continued to be a stalwart for racial equity years later while attending Fort Lauderdale High School. Moore took a stand on behalf of his black peers by leading a demonstration that successfully led to black students being able to participate in extracurricular activities.

Decades later, Mr. Moore continued making a tremendous impact on the City of Fort Lauderdale and its citizens, while serving as City Commissioner of District III for 20 years. In this capacity, his commitment to the city, in which he was raised, became crystal clear through several of his achievements and accomplishments. He was known as a strong advocate for improving the city's predominantly black northwest corridor and worked to revitalize neighborhoods and businesses in this area, spearheading initiatives in affordable housing, economic development and job creation.

Carlton B. Moore is deserving of this award because he was always on the front line fighting for the people of Fort Lauderdale. He advocated making sure the voices of his community were heard. He first began his service in 1973 when he entered law enforcement as a police officer. Bruce saw service as a patrol officer and detective. He worked his way through the ranks to his appointment as Chief of Police. He served in that position from October 2001 until May 2008. As Chief, Bruce enabled Fort Lauderdale to enjoy the two lowest crime rates in the history of the City since 1974. Under his leadership, the Police Department was removed from a consent decree from the U.S. Department of Justice Civil Rights Division because of the improvements he made to diversity hiring and promotion. The Department earned reaccreditation twice by the Commission for Florida Law Enforcement Accreditation.

His efforts as a police officer, and ultimately Chief, provided a secure and safe place for the citizens of Fort Lauderdale to live and work from the youngest to the oldest. That safety was a fundamental benefit to the balanced economic growth of the City of Fort Lauderdale. Several of the command staff who worked for and were promoted by Bruce are now Chiefs of Police in cities across the United States, further adding national distinction to the City of Fort Lauderdale as a place to visit and live.

Bruce continued his public service in 2009 by serving as City Commissioner in District 1, including serving as Vice Mayor. He expanded transparency and public participation in decision making by the City. He emphasized continued progress in public safety and the rational development of Fort Lauderdale balanced against appropriate environmental concerns. - The Police Department was removed from a consent decree from the U.S. Department of Justice Civil Rights Division because of the changes made specifically to diversity hiring and promotion in the Department.

• The Department earned reaccreditation twice by the Commission for Florida Law Enforcement Accreditation.

These accomplishments required that Bruce incorporate his working knowledge of other City departments and his relationships with other department directors and agencies. Examples include coordination of services for events such as the Air & Sea Show, the Boat Show, and the Organization of American States Conference. These services are drawn from Police, Fire-Rescue, Public Works, Parks, the City Attorney, Budget Office, and Procurement. The recognition for achieving a diverse Police Department could not have been accomplished without meshing the department's hiring plan with resources from the Human Resources Department and the City Attorney's Office.

Bruce then served with distinction as City Commissioner for District 1 in Fort Lauderdale starting in 2009 for two consecutive terms, including as Vice Mayor. 


