NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the scheduled September 2, 2025, Conference and Regular Meetings of the City Commission of the City of Fort Lauderdale, Florida, are hereby rescheduled to September 3, 2025, commencing at 1:30 p.m. Public hearings, ordinances, resolutions, and motions shall be heard commencing at 6:00 p.m. on September 3, 2025.

<u>SECTION 2</u>. That the City Clerk shall publish this resolution in the official newspaper of the City once at least three (3) days before September 2, 2025.

<u>SECTION 3</u>. That any resolution or part of a resolution in conflict herewith be, and is hereby rescinded to the extent of such conflict.

SECTION 4. That this Resolution shall be in full force and effect upon its adoption.
