In July 2024, Fort Lauderdale Fire-Rescue transitioned from 5.5 technology based self-contained breathing apparatuses (SCBA) to 4.5 SCBAs throughout the entire department. The City of Oakland Park Fire-Rescue currently uses 5.5 SCBAs and is a growing department. By donating the retired (20) 5.5 SCBAs to Oakland Park Fire-Rescue, it provides a neighboring fire department with additional lifesaving equipment for responding to calls in its own jurisdiction.

The donation also allows Oakland Park to streamline replacements should its inventory of 5.5 SCBAs be depleted, become defective or need to be replaced and swapped out during an emergency response.

Through acceptance of the donation, Oakland Park agrees that it is acquiring said equipment in “as is” condition and is assuming all associated liability, understanding that the City of Fort Lauderdale is not providing any warranty on the equipment.
