## Recommendation

Staff recommends the City Commission adopt a resolution accepting two Cox CXO300hp outboard engines, installation, and twelve months of service from Ring Power Corporation in exchange for allowing Ring Power Corporation to conduct certain marketing activities, waiving the competitive solicitation and selection processes contained in Division 2, Procurement, of Chapter 2, Article V, of the Code of Ordinances of the City of Fort Lauderdale, Florida, for the acquisition of the engines, and approving a Marketing Agreement between Ring Power Corporation and the City of Fort Lauderdale.

## **Background**

Ring Power Corporation is a Florida-based company that serves numerous industries, including the marine industry, and is the exclusive representative of Cox Powertrain Technology in Florida. Ring Power Corporation desires to donate 2 CXO300 diesel outboard engines to the City of Fort Lauderdale for exclusive use on a Police Department Marine Unit vessel in exchange for the City's agreement to allow Ring Power Corporation to conduct certain marketing activities.

The CXO300 produces 20-35% less CO2 emissions than comparable gasoline outboards. With up to 30% fuel savings, producing 30% less CO2 emissions, and with 479 lb. ft torque, the diesel outboard is an environmentally friendly and efficient propulsion option. The CXO300 has successfully achieved Environmental Protection Act (EPA) Tier 3, and International Maritime Organization (IMO) II certifications. The engines currently on the vessel have accumulated over 4,000 hours of operation, require frequent service/repairs, and have reached the end of their useful service life. Department vessels are often the first to respond to occurrences of marine accidents, potential drownings, and other water-related emergencies. It is imperative that the Police Department Marine Unit vessels remain in excellent working order and have reliable engines to conduct these essential operations.

Ring Power Corporation will also remove the existing engines and install the donated engines, including any necessary parts/accessories, at their expense as part of the donation. Additionally, Ring Power Corporation will also include 12 months of service on the donated engines.

# **Resource Impact**

This action will result in a positive impact to the City. The value of the donated equipment – two (2) CXO300 engines, installation and 12 months of service is \$160,000.

- Two (2) Cox CXO300 engines @ \$65,000/ea. = \$130,000
- Installation (including necessary parts/accessories) @ \$25,000
- 12 months service @ \$5,000
