WHEREAS, the City Commission of the City of Fort Lauderdale, Florida at its meeting of June 21, 2011, authorized the proper officials by motion to execute an Agreement between CONSULTANT and CITY authorizing the performance of services in connection with an Agreement for General Environmental Engineering Consultant Services, RFQ # 616-10632 (the "Agreement"); and

WHEREAS, on July 6, 2011, MACTEC Engineering and Consulting, Inc. filed a name change amendment with the Florida Department of State to change their name to AMEC E&I, Inc. on their Articles of Incorporation effective July 5, 2011; and

WHEREAS, on November 9, 2011, AMEC E&I, Inc. and AMEC Environment & Infrastructure, Inc. entered into an Agreement and Plan of Merger ceasing the existence of AMEC E&I, Inc., transferring all rights, privileges, duties, liabilities, property, debt and every other interest and making it a 100% owned direct subsidiary of AMEC Environment & Infrastructure, Inc. effective January 1, 2012; and

WHEREAS, Section 6.1 of the Agreement authorizes renewal for three (3) successive one (1) year terms upon mutual consent of the parties; and

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida at its meeting of June 5, 2012, authorized the proper officials by motion to execute a First Extension and Amendment to Agreement between CONSULTANT and CITY authorizing the performance of services until June 20, 2013; and

WHEREAS, CITY wishes to retain CONSULTANT to provide, and CONSULTANT desires to provide, contracted professional consultant services to CITY for an additional

one year (1) period until June 20, 2014, utilizing the contract prices of the original Agreement; and

WHEREAS, at its meeting of \_\_\_\_\_\_, 2013, the City Commission, by motion, authorized the proper City Officials to execute this Second Extension to Agreement;

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants, agreements, terms, and conditions contained herein, do agree as to the following:
