TITLE: Motion to Approve Contracts for Purchase of Fire Rescue Uniforms – Multiple Vendors – \$122,301

Recommendation

It is recommended that the City Commission approve contracts, in substantially the forms attached, for the purchase of fire rescue uniforms from multiple vendors for a one-year period in the estimated amount of \$122,301; and authorize the City Manager to approve three one-year renewal options contingent upon approval and appropriation of funds.

Background

On June 14, 2017, the Procurement Services Division issued Invitation to Bid No. 872-11990 for fire rescue uniforms and received 13 bids. Awards will be made by line items (as detailed in Exhibit 1) to the lowest bidders that have met all of the specifications of the bid and have been deemed the lowest cost, responsive and responsible bidders.

Award will be made to the following vendors:

- The Great Armadillo Printing Co, LLC., Amarillo, TX
- Gold Nugget Uniform, Inc. d/b/a Argo Uniform Co., Hallandale Beach, FL

Resource Impact

There will be a current fiscal impact to the City in the estimated amount of \$20,000. Future expenditures are contingent upon approval and appropriation of funds.
