

RESOLUTION NO. 24-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING AND AUTHORIZING EXECUTION OF A STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION DISTRICT FOUR MAINTENANCE MEMORANDUM OF AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION, TO RELOCATE AND INSTALL CHAIN LINK FENCING AND TO MAINTAIN THE IMPROVEMENTS WITHIN THE RIGHT-OF-WAY OF THE STATE ROAD (SR) 862/I-595 SOUTHBOUND ON-RAMP, TO STATE ROAD (SR) 9/I-95 SOUTH, TO SOUTHWEST 32<sup>ND</sup> PLACE; PROVIDING FOR CONFLICTS, PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Fort Lauderdale, Florida ("City") wishes to enter into a Maintenance Memorandum of Agreement ("MMOA") with the Florida Department of Transportation ("FDOT") for the purpose of relocating and installing approximately 550 Linear feet of chain link fencing (improvements) and maintaining the landscape and drainage area from the toe of the bank to the top of the bank (landscape and drainage area) within FDOT's right-of-way, along the State Road (SR) 862/I-595 southbound on-ramp, to SR-9/I-95 South, to SW 32<sup>nd</sup> Place; and

WHEREAS, the improvements will be installed in accordance with the plans and specifications of the MMOA; and

WHEREAS, because SR 862/I-595 and SR-9/I-95 are FDOT rights-of-way, authorization for this work must be permitted by FDOT; and

WHEREAS, FDOT requires municipalities to enter into a Maintenance Memorandum of Agreement for the maintenance of the improvements and landscape and drainage area;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Commission of the City of Fort Lauderdale, Florida, hereby approves and authorizes the execution of a State of Florida Department of Transportation District Four Maintenance Memorandum of Agreement with the Florida Department of Transportation, to relocate and install chain link fencing and to maintain the improvements within the right-of-way of the State Road (SR) 862/I-595 southbound on-ramp, to State Road (SR) 9/I-95 South, to Southwest 32<sup>nd</sup> Place.

SECTION 2. That the Office of the City Attorney shall review and approve as to form all documents prior to their execution by the City Manager.

SECTION 3. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4. If any clause, section, or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and in no way affecting the validity of the other provisions of this Resolution.

SECTION 5. That this Resolution shall be in full force and effect upon its adoption.
