**TITLE:** **REVISED PUR-4** - Motion to Approve Public Art Located at 200 Northwest  
 Sistrunk Boulevard - \$150,000

**Recommendation**

It is recommended that the City Commission approve an agreement, in substantially the form attached, for a proprietary purchase in the amount of \$150,000 for public art work on the Sistrunk corridor.

**Background**

As part of the Fort Lauderdale Centennial Celebration, \$150,000 was earmarked to provide public art along the Sistrunk corridor. After working closely with neighborhood representatives and local artist, George Gadson, the Sankofa Bird with Egg Statue (see Exhibit 1) is proposed for the park area located at the southwest corner of Sistrunk Boulevard and NW 2<sup>nd</sup> 27<sup>th</sup> Avenue.

Pursuant to Section 2-189 (c)(1), Code of Ordinances of the City of Fort Lauderdale Florida, the City may purchase proprietary items without public bids. Proprietary items, such as works of art for public places, are defined in Section 2-173 of the Code of Ordinances.

**Resource Impact**

There will be a fiscal impact to the City in the amount of \$150,000.
