

**FIRST EXTENSION TO

AGREEMENT (FY 2020 – 2021)**

This is a FIRST EXTENSION to a CITY OF FORT LAUDERDALE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM PUBLIC SERVICE PROGRAM PARTICIPATION AGREEMENT (FY 2020 – 2021), entered into on this 1st day of October 2021, between:

CITY OF FORT LAUDERDALE, a municipal corporation of
the State of Florida, hereinafter referred to as "CITY,"

and

BROWARD PARTNERSHIP FOR THE HOMELESS, INC.,
a non-profit corporation organized under the laws of the State of
Florida whose usual place of business is a 920 NW 7TH
AVENUE, FORT LAUDERDALE, FL 33311 hereinafter
referred to as "Participant."

WHEREAS, pursuant to a CITY OF FORT LAUDERDALE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM PUBLIC SERVICE PROGRAM PARTICIPATION AGREEMENT (FY 2020 – 2021) dated November 10, 2020 ("Participation Agreement"), CITY engaged the services of the Participant to administer a CDBG 2020-2021 Homeless Assistance Center Program; and

WHEREAS, pursuant to Article II, Term and Time of Performance, the Participation Agreement shall end on September 30, 2021, although the parties may extend the term of the Participation Agreement in writing by the HCD Manager based on circumstances not under Participant's control; and

WHEREAS, the parties desire to enter into a first extension to extend the term of the Participation Agreement to March 31, 2022; and

NOW, THEREFORE, in consideration of the mutual promises and covenants hereinafter contained and other good and valuable considerations, the CITY and Participant agree to extend the Participation Agreement as follows:

1. The foregoing recitals are true and correct and incorporated herein by reference.
2. Pursuant to Article II, Term and Time of Performance, the Participation Agreement, the term is hereby extended from September 30, 2021 to March 31, 2022.
3. In the event of any conflict or ambiguity by and between the terms and provisions of the Participation Agreement, the terms and provisions of this First Extension to the Participation Agreement shall control to the extent of any such conflict or ambiguity.

4. This First Extension to the Participation Agreement shall take effect upon execution by both parties.


5. The terms and conditions of the Participation Agreement shall remain in full force and effect, except as specifically amended by this First Extension to the Participation Agreement.



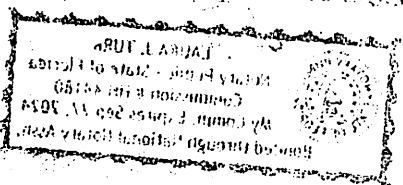
