**TITLE**: Consent Resolution – Memorandum of Agreement to Reimburse Customs

and Border Protection for Providing Information Technology Services -

Project 11242 – Executive Airport

## Recommendation

It is recommended that the City Commission approve a resolution authorizing the City Manager to execute a Memorandum of Agreement to reimburse Customs and Border Protection for providing Information Technology equipment and services estimated at \$208,349.68 and annual support costs for the services in the amount of \$5,179.32 for the U.S. Customs and Border Protection Facility.

## Background

The U.S. Customs and Border Protection Facility is currently under construction with an anticipated completion date of March 2015. As part of equipping the facility prior to it becoming operational, Customs and Border Protection (CBP) was to purchase and install all Information Technology equipment and services. However, due to budget cuts resulting from the sequestration in 2013 funds were no longer available to fund the equipment purchase and installation. The Airport was informed of the changes in March 2013 (Exhibit 1). As a result, the City is now required to enter into a Memorandum of Agreement (MOA) with CBP to reimburse them for the purchase, installation, connectivity, and equipment upgrades of the Automated Data Processing equipment.

This equipment includes workstations, monitors, network switches, scanners, fingerprint scanners, cameras, printers, and additional equipment for a complete working system. The estimated amount for the above equipment and services is estimated at \$208,349.68. The MOA also includes annual support costs for the services in the amount of \$5,179.32 (Exhibit 2).

Staff has reviewed the MOA with the City's Legal Department and Procurement Services Division and both departments have no objection to proceeding with the agreement.

This item was reviewed and approved by the Aviation Advisory Board at its March 27, 2014 meeting.

## **Resource Impact**

There is a fiscal impact to the City in the amount of \$208,349.68 for FY 2014 and recurring annual support impact of \$5,179.32.
