TITLE: Public Hearing - Resolution Granting a Waiver of Limitations at 2407 Aqua Vista Blvd., for the Installation of a Platform Boat Lift and a Platform Jet Ski Lift – **(Commission District 2)**

Recommendation

Staff recommends the City Commission adopt a Resolution, pursuant to Unified Land Development Regulations (ULDR) 19.3(e), granting a Waiver of Limitations for the installation of a boat lift and a jet ski lift located at 2401 Aqua Vista Blvd.

Background

The applicant is seeking a Resolution, pursuant to ULDR 47-19.3(e) granting a Waiver of Limitations (a waiver to allow mooring structures to extend beyond the maximum distance as defined by City Code) of Section 47-19.3 (c) of the Unified Land Development Regulations (ULDR) for the installation of a no-profile boat lift extending a maximum distance of +/- 34.5 feet from the property line into the waters of the Intracoastal Waterway (ICWW). The applicant's Summary Description specifies that the proposed boat and jet ski lifts are necessary to protect the owner's vessel during high wind events and severe weather, large wakes from boat traffic, and to allow for light penetration and natural resource protection.

Although there is not a fee associated with obtaining a Waiver of Limitations, an application fee in the amount of \$1500.00 is required.

The Marine Advisory Board recommended unanimous approval of the revised application 8 to 0 at the February 4, 2021 meeting (Exhibit 3).

Resource Impact

There is a positive fiscal impact in the amount of \$1,500. Revenue related to the application fee is included in the FY2021 Operating Budget in the account listed below.
