That the City of Fort Lauderdale's FY 2024 Final All Funds Budget for the Fiscal Year beginning October 1, 2023, and ending September 30, 2024, as amended, is hereby amended by appropriating funds as set forth in City Commission Agenda Memo #23-1205, a copy of which is attached hereto and incorporated herein.

<u>SECTION 2</u>. That if any clause, section, or other part of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Resolution shall not be affected thereby, but shall remain in full force and effect.

## Recommendation

Staff recommends the City Commission adopt a resolution amending the Fiscal Year (FY) 2024 Operating Budget.

### **Background**

Examples of recommended actions within the budget amendment are:

- transfer between funds;
- transfer between capital and operating budgets;
- · transfer between capital projects;
- acceptance and appropriation of grant funding;
- · amendment to staffing level;
- · appropriation from fund balance; and
- appropriation for modified revenue and related expenditures.

Staff recommends the City Commission amend the FY 2024 Final Budget, as amended, by approving the following appropriations:

### **Human Resources**

## A. Appropriation from Fund Balance – General Fund – Fraternal Order of Police (FOP) Collective Bargaining Agreements - \$758,610

The previous collective bargaining agreement between the City of Fort Lauderdale and Fort Lauderdale Police Lodge 31, Fraternal Order of Police - Lieutenants and Captains, expired on September 30, 2022. The City and the collective bargaining unit have reached two (2) new tentative agreements – the first will cover one (1) year (October 1, 2022, through September 30, 2023) and the second will cover three (3) years (October 1, 2023, through September 30, 2026). Financial summaries are provided in the associated CAMs 23-1086 and 23-1087 for the collective bargaining agreements. The estimated impact of the FOP agreements is \$758,610; \$433,785 for agreement 1 and \$324,825 for agreement 2.

Staff recommends the Commission amend the FY 2024 Operating Budget in the amount of \$758,610 for the Fraternal Order of Police Collective Bargaining Agreements.

# B. Appropriation of Grant Funds – Grant Fund – Occupant Protection Safety Campaign grant acceptance - \$60,000

In February 2023, the City submitted an application to the Florida Department of Transportation (FDOT) in response to a solicitation for proposals from law enforcement agencies to address the most significant traffic safety issues within their jurisdictions. The City has been awarded \$60,000 in funding to institute an occupant protection safety campaign to reduce the frequency of incidents in identified hot spots. Education and enforcement activities will be performed in order to improve safety belt awareness and use. The grant does not require matching funds and will end on September 30, 2024.

Staff recommends the City Commission amend the FY 2024 Operating Budget in the amount of \$60,000 for the FY 2024 FDOT State Safety Office Program grant for the occupant protection safety campaign.
