A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING THE MUTUAL DATA SECURITY AND PUBLIC RECORDS COMPLIANCE AGREEMENT BETWEEN THE CITY OF FORT LAUDERDALE AND TRIMBLE INC., AUTHORIZING THE CITY MANAGER TO EXECUTE THE MUTUAL DATA PUBLIC SECURITY AND RECORDS COMPLIANCE AGREEMENT, AND PROVIDING FOR SEVERABILITY, RESCISSION OF CONFLICTING RESOLUTION PROVISIONS, AND AN EFFECTIVE DATE.

WHEREAS, Cityworks will serve as a critical component of the City of Fort Lauderdale's ("City") operational framework, facilitating essential functions such as infrastructure asset management, work order tracking, and spatial data analysis; and

WHEREAS, in order to move the City's data to the Cityworks Online platform, the City's Information Technology Department ("ITS") requires that we have full confidence in Trimble Inc.'s ("Trimble") security measures and compliance standards with their attainment of System and Organization Controls 2 ("SOC2") certification, which demonstrates that an organization has implemented robust controls and procedures to safeguard sensitive data and ensure the security, availability, processing integrity, confidentiality, and privacy of customer information; and

WHEREAS, given the sensitive nature of the data managed within Cityworks Online, and the potential negative impact of any security breach to our organization, it is essential that the City's ITS thoroughly assess Trimble's SOC2 certification; and

WHEREAS, due to the proprietary nature of the information contained within Trimble's SOC2 certification, Trimble requires the City to execute a Mutual Data Security and Public Records Compliance Agreement before they will release it for City's review; and

WHEREAS, Staff recommends the execution of the Mutual Data Security and Public Records Compliance Agreement, in order to move forward with the final stages of the Cityworks Online system implementation;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. The City Commission of the City of Fort Lauderdale, Florida, hereby approves the Mutual Data Security and Public Records Compliance Agreement between the City of Fort

Lauderdale and Trimble Inc. ("Agreement"), in substantially the form attached to City Commission Agenda Memo #24-0561, and the City Manager is authorized to execute the Agreement.
