Requested Proposal Revisions:

1. Playing Cards have been deleted from Sand Castle display
2. Materials for manufacture of the Sand Castle
 - a. Commercial Grade Plywood and Aluminum
 - b. Industrial Strength Foam
 - c. Sand Textured Paint
 - d. Outdoor-Commercial Grade Adhesive
 - e. Outdoor props, fabric and material
 - f. MCL commercial grade 5MM LED mini lights
 - g. Custom designed figurines
 - h. High quality wreaths
 - i. Fort Lauderdale Beach Sand
3. Revised size of Sand Castle from 10' X 10' at a cost of \$40,000, to an increased size of 15' X 15' at a cost of \$50,000.
4. Sand Castle has been elevated on a 20' X 30' platform at approximately 48" in height to assist in preventing vandalism at a cost of \$5,000.
5. "Fort Lauderdale Beach" has prominently displayed on platform to allow for photo opportunities.
6. 2014 Proposal for RFP City of Fort Lauderdale Holiday Décor B Rev Opt 1-Surfboard pole lights on both sides of SR A1A
 - Convert all 101 lamp post décor on the East side of A1A from wrapping the poles with ribbon with 2 bows at the top, to installing 4' frame shaped like a surfboard, outlined in WW C7s and with brackets attached to the lamp post. Banners-18" X 2'-3' attached within the surfboard structure. The banners are customized to a saying or expression of happy holidays by the community.
 - For all 65 25' concrete poles, instead of alternating and having half of the concrete poles with just a banner only along the West side of A1A; 7' frame shaped like a surfboard, outlined in WW C7s and with brackets attached 10' up on the lamp post. Banners-4' tall attached within the surfboard structure. The banners are customized to a saying or expression of happy holidays by the community.
7. 2014 Proposal for RFP City of Fort Lauderdale Holiday Décor B Rev Opt 2-Surfboard pole lights on both sides of SR A1A
 - Convert all 101 lamp post décor on the East side of A1A from wrapping the pole with ribbon with 2 bows at the top to installing 4' frame shaped like a surfboard, outlined in WW C7s and with brackets attached to the lamp post. Banners-18" X 2'-3' attached within the surfboard structure. The banners are customized to a saying or expression of happy holidays by the community.
 - As in the original Décor B Proposal-On the West side of A1A, for 33 of the concrete poles, there will be installed, 7' frame shaped like a surfboard, outlined in WW C7s and with brackets attached 10' up on the lamp post. There will be banners-4' tall attached within the surfboard structure. They will be

alternating with 32 concrete poles-with 4' banners only, attached with brackets to the lamp post. All banners are customized to a saying or expression of happy holidays by the community.

8. All or parts of the display may be left up until the end of February 2015 at the discretion of the City of Fort Lauderdale
