TITLE: Motion Approving Increase to the Annual Construction of General Stormwater Infrastructure Contracts – Various Contractors - \$10,420,219 – **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission approve an increase to the Annual Construction of General Stormwater Infrastructure Contracts with FG Construction, LLC; Man-Con, Inc.; Southern Underground Industries; David Mancini & Sons; Southeastern Engineering Contractors; and DP Development, LLC in the aggregate amount of \$10,420,219, from \$14,000,000 to \$24,420,219, effective through the initial period ending October 30, 2027.

Background

On October 7, 2025, the City Commission awarded the Annual Construction of General Stormwater Infrastructure Continuing Contracts (Invitation to Bid Event No. 468-1, CAM #25-0821) to FG Construction, LLC; Man-Con, Inc.; Southern Underground Industries, Inc.; David Mancini & Sons, Inc.; Southeastern Engineering Contractors, Inc.; and DP Development, LLC. These Continuing Services Agreements (CSA) were awarded for a two (2)-year term with three (3) one (1)-year renewal options. Through the Task Order process, the CSAs will fund the construction services for stormwater management improvements necessary to maintain and operate various stormwater assets during this period.

The City applied for reimbursement from the Federal Emergency Management Agency (FEMA) for disaster recovery efforts following the April 2023 flood event. After a ten (10)-month project to desilt and inspect stormwater pipes and other infrastructure in flood-impacted areas, the City identified additional stormwater repair and restoration work associated with the flood. FEMA is expected to reimburse the City seventy-five percent (75%) of the cost of the repairs. The State of Florida will reimburse twelve and one half percent (12.5%), leaving the City responsible for the remaining twelve and one half percent (12.5%).

City staff have assessed and prioritized damages requiring repair or replacement and seek to use these CSAs to support the additional construction activities. The estimated cost of these repairs, submitted to FEMA and developed by staff, is approximately \$10,420,219. An increase in the cap for the initial period of the CSAs is needed to accommodate these repairs

as well as the non-FEMA related annual maintenance and operations of stormwater assets.

Resource Impact

There is a current fiscal impact to the City in the amount of \$2,716,627 associated with the FEMA-related contract expenses. Future task order funding for non-FEMA related annual maintenance and operations of stormwater assets is contingent upon the approval and appropriation of the annual budgets.
