**Name:** Aquatic Program Management - Sunrise Middle Pool (rebid)

**Description:** The City of Fort Lauderdale, Florida (City) is seeking bids from qualified, experienced, and licensed firm(s), hereinafter referred to as the Contractor or Bidder, to provide a revenue- generating aquatic program including but not limited to classes, practices (swim team), community recreational use (lap swim, recreational swim, learn to swim, etc.) and specialty instruction/clinics, for the City, in accordance with the terms, conditions, and specifications contained in this Invitation to Bid (ITB). The pool at Sunrise Middle School is jointly operated by the School Board of Broward County (SBBC) and the City of Fort Lauderdale.

Bidders must bid no lower than the minimum annual guarantee (MAG) of 18,000, which is to be reflected as a minimum monthly fee of \$1,500 (i.e. 12 months x \$1,500 minimum monthly fee = \$18,000 (MAG)) as a Unit Price on the Bid Line Item to be deemed responsive to this solicitation.

Award of this contract will be made to the responsive and responsive bidder meeting the specifications who bids the "highest" minimum annual guarantee (MAG). Bidder must offer its (MAG) as a minimum monthly fee as a Unit Price on the Bid Line Item. The City's on- line strategic sourcing platform will multiply the minimum monthly fee by 12 (Quantity) months (Unit of Measure). The Extended Amount shall be considered bidder's "highest" offer as its minimum annual guarantee (MAG).

Failure to adhere to the bidding requirements contained in this Section shall deem your bid non-responsive.

The initial contract term shall commence upon final execution of the contract by the City and shall expire one year from that date or the day after the current contract expires, whichever is later. The City reserves the right to extend the contract for three additional one-year terms providing all terms conditions and specifications remain the same, both parties agree to the extension, and such extension is approved by the City.
