TITLE: Motion Approving Second Amendment(s) to the Consolidated Regional E-911 Communications System and the Regional Interlocal Agreement Between Broward County and the City of Fort Lauderdale for Cooperative Participation in a Regional Public Safety Intranet – **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission approve the second amendment(s) to the Consolidated Regional E-911 Communications System ("Participation Agreement") and the Regional Interlocal Agreement ("RILA") between Broward County and the City of Fort Lauderdale for Cooperative Participation in the Regional Public Safety Intranet.

Background

On September 3, 2013, the City Commission approved the City's participation in the consolidated regional E-911 communications system with Broward County ("County") known as the Participation Agreement (CAM #23-0671). In conjunction with entering into the Participation Agreement each municipality also entered a Regional Interlocal Agreement ("RILA") to migrate 911 dispatch services into the County's Computer Aided Dispatch System (CAD) communication platform. On August 3, 2020, Broward County Administrator requested municipal managers approve the amended agreements to align with the performance standards of the Operator Agreement the County has with the Broward Sheriff's Office ("BSO"). On September 30, 2023, Broward County requested municipal managers approve the second amendment to the 'user agreements' to extend the term for 5 additional years, expiring in year 2028.

Resource Impact

There is no current fiscal impact for this item. Future fiscal year expenditures are contingent upon Commission adoption of annual operating budgets.

This item is a *2024 Commission* Priority, advancing the Public Safety initiative.
