TITLE: GRANT ACCEPTANCE

United States Department of Justice, 2012 Bulletproof Vest Partnership

Grant Program, \$8,621.11, City Match Required

Recommendation

It is recommended that the City Commission approve a motion authorizing the proper City officials to accept a grant from the United States Department of Justice and execute any documents required to accept funds between the United States Department of Justice and the City of Fort Lauderdale.

Background

The City is accepting a grant in the amount of \$8,621.11. The grant reimburses only 50% of the cost of allowable expenses. Funds will be used to purchase bulletproof vests. The program period is April 1, 2012 through August 31, 2014.

Special Conditions

The United States Department of Justice requires that agencies receiving Bulletproof Vest Partnership Grant Program funds have a mandatory wear policy in effect. The grant program does not require execution of a formal agreement for acceptance of awarded funds; instead, funds are posted directly to the City's account in the Bulletproof Vest Partnership System.

Resource Impact

There is a positive fiscal impact to the City in the amount of \$8,621.11. Matching funds in the amount of \$8,621.11 have been identified in the General Fund. Appropriation of funds is contingent upon approval of consolidated budget amendment item 12-2466.
