**TITLE**: Motion Authorizing Purchase of Reinsurance for Self-Funded Medical Plan

– Cigna Health and Life Insurance Company – \$755,073.

#### **Recommendation**

It is recommended that the City Commission approve the purchase of reinsurance with a stop loss level of \$275,000 for the self-funded medical plan from Cigna Health and Life Insurance Company ("Cigna") in the estimated amount of \$755,073, and determine that Cigna best meets the needs of the City, as provided in Section 2-199(1), Code of Ordinances of the City of Fort Lauderdale.

## **Background**

The City of Fort Lauderdale's self-funded medical plan design includes a fully insured specific reinsurance policy that covers all incurred medical and pharmacy claims in excess of a designated amount per member per calendar year. This coverage is also known as a specific stop loss policy. These reinsurance policy premiums are only guaranteed for one year at a time and renewals are based on local industry medical cost trends, policy experience, and an insurance company's overall experience in their reinsurance pool.

The City of Fort Lauderdale's current reinsurance policy is underwritten by Cigna and is scheduled to expire on December 31, 2016. As provided in Section 2-199(1) of the Code of Ordinances, the City's contracted agent, Lloyd Rhodes of The Rhodes Insurance Group, conducted negotiations with the current vendor, Cigna, and obtained a 10% increase in premium (\$44.69 per subscriber, per month, up from \$40.63) while retaining the same stop loss level of \$275,000. However, if the City renews with Cigna, they will provide a 2-month credit of Administrative Services Only (ASO) fees in January and February 2017 estimated to be a total of \$119,658. Therefore the City will save 5% or an estimated \$40,137 annually based on current enrollment data. This policy is for the period of January 1, 2017 through December 31, 2017. The Insurance Advisory Board reviewed and approved this item at their September 7, 2016 meeting.

Staff, and by recommendation from the Insurance Advisory Board and the City's Benefits Consultant, requests City Commission approval for the purchase of

reinsurance from Cigna Health and Life Insurance Company in the estimated amount of \$755,073.

There will be an estimated fiscal impact to the City in the amount of \$755,073.

If the City renews the reinsurance agreement with Cigna they will provide a 2 month credit of ASO fees in January & February 2017 estimated to be \$119,658

Note - 2018 Reinsurance Premium will be based on the 2017 Annual Premium not including the ASO fee credit.
