A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE FORT LAUDERDALE COMMUNITY REDEVELOPMENT AGENCY AMENDING RESOLUTION NO. 21-16 (CRA) AND RESOLUTION NO. 22-06 (CRA); APPROVING AN INCREASE IN FUNDING FROM EIGHT MILLION AND NO/100 DOLLARS (\$8,000,000) TO NINE MILLION AND NO/100 DOLLARS (\$9,000,000) TO INVEST FORT LAUDERDALE, INC. FOR "THE ALDRIDGE" AND "THE LARAMORE" MIXED-USE AFFORDABLE HOUSING PROJECT, LOCATED AT 1017 SISTRUNK BLVD., 1204 SISTRUNK BLVD. AND 1620 NW 6TH COURT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on November 16, 2021, pursuant to Resolution No. 21-16 (CRA), the Board of Commissioners of the Fort Lauderdale Community Redevelopment Agency (the "CRA") approved funding in the amount of \$8,000,000 to Sistrunk Apartments, LLC for "The Aldridge" and "The Laramore" mixed-use affordable housing (the "Project"); and

WHEREAS, on July 5, 2022, pursuant to Resolution No. 22-06, the Board of Commissioners of the CRA amended Resolution No. 21-16 to change the Borrower to Invest Fort Lauderdale, Inc. and to add a requirement for a Guarantor; and

WHEREAS, there is a gap in financing due to rising construction costs and a drop in demand for Low Income Housing Tax Credits; and

WHEREAS, at the December 10, 2024, meeting of the Northwest-Progresso-Flagler Heights CRA Advisory Board, the Advisory Board unanimously recommended approval of the additional \$1,000,000.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE FORT LAUDERDALE COMMUNITY REDEVELOPMENT AGENCY:

<u>SECTION 1</u>. That the Recitals set forth above are true and correct and incorporated herein by this reference.

<u>SECTION 2</u>. That the Fort Lauderdale Community Redevelopment Agency hereby approves additional funding under the CRA's Development Incentive Program in the amount of One Million and No/100 Dollars (\$1,000,000) to Invest Fort Lauderdale, Inc. which shall increase the overall funding to Nine Million and No/100 Dollars (\$9,000,000).
