# Welcome to Florida, now here's a face mask

TALLAHASSEE -Two state-operated welcome centers opened to the public this week for the first time since March, while the coronavirus pandemic keeps two others shut down.

And while the highway centers were once known for offering free orange juice to weary travelers, state workers at the reopened facilities on Interstate 10 near the Alabama border and Interstate 75 near the Georgia border are providing free face masks as part of COVID-19 protocols.

Visit Florida President and CEO Dana Young said more than 400,000 masks have been made available by the state Department of Health and the Division of Emergency Management's State Emergency Response

"They will be for our staff, and we will be making these available freely to the public throughout the summer if they desire to pick one up while they are visiting our state," Young said during a Visit Florida Executive Committee conference call Monday.

The welcome-center openings come after the state on June 5 ended a motorist checkpoint on I-10 near the Alabama border set up in late March as part of an effort to require people traveling from Louisiana, then a COVID-19 hotspot, to self-isolate if they entered Florida.

Still not open is a welcome center along Interstate 95 and a Visit Florida kiosk inside the Florida Capitol, which remains

is just north of a weigh station being used as a COVID-19 checkpoint for motorists from the disease hotspots of New York, New Jersey and Connecticut. "We are really looking

forward to being able to reopen the I-95 welcome center, and we hope to have more news on that in the coming days," Young said.

At the checkpoints, motorists have been required to complete forms that include contact information

and trip details. The state collected nearly 28,000 traveler forms at the I-10 checkpoint.

More than 35,700 forms had been collected at the I-95 checkpoint as of Monday, according to the state Department of Transporta-

When the respiratory virus caused the closing of many state agencies, at least 16 of the 20 people who work at the state's welcome centers were trained to handle phone calls from small business owners for the Department of Economic Opportunity.

The opening of the centers comes as Visit Florida, the state's tourism-marketing agency, is finalizing a "rebounder" marketing campaign that will initially concentrate on getting Floridians to become comfortable traveling in the state.

# Large crack found in southbound span of Roosevelt Bridge

Vehicle traffic was detoured and commercial boating traffic halted at the Roosevelt Bridge in Stuart due to emergency repairs after a crack appeared on the underside of a segment of the bridge during a routine inspection.

A large crack developed at the base of the south end of the bridge forcing the bridge to be closed indefinitely until repairs are completed, the Florida Department of Transporta-

"Safety is always our number one priority," Gerry O'Reilly, FDOT District 4 Secretary, said in a statement. "We are systematically assessing every aspect of the structure at this time."

The Roosevelt Bridge is two separated bridges with three lanes each on each span that have been closed until a thorough safety inspection is completed. The stretch of Dixie Highway that passes under the bridge is also closed.

"Some concrete fell from underneath the Roosevelt Bridge on the southbound side," said Stuart police Sgt. Brian Bossio. "It's unknown why it hap-

The Coast Guard has set up a safety zone in the area to prevent any commercial boating traffic from going under the bridge. The



The south lanes of the Roosevelt Bridge have been closed to vehicular and boating traffic because of a large crack that formed at the south end, Stuart police said.

Coast Guard also issued an advisory via radio overnight.

A statewide team of bridge experts has been assembled. Teams were on site assessing the situation and performing a full structural review. The waterway and Florida East Coast railroad corridor remain unaffected at this time, FDOT officials said.

Motorists and pedestri-

ans wishing to cross the St. Lucie River on Dixie Highway should follow detour signs as posted. Police are on site to direct traffic.

The new Roosevelt Bridge was built in 1996 and spans the St. Lucie River in Martin County.

DAVIE – Davie residents in at least 10 communities are being advised to boil their water following a water main break impacting hundreds of homes

The town issued a boil water notice Tuesday night for properties between Orange Drive and Southwest 25th Street from South Hiatus Road to Nob Hill Road after a water main broke around 4:20 p.m. the town said in a statement.

Communities impacted by the notice include, but are not limited to, Davie West, Davie Farmettes, Hiatus Ranchettes, Long Lake Ranches, Mystique Estates, Hiatus Isles, Lawson Isles, Blackhawk Reserve, Camelot Estates

and Long Lake Estates. Water should be boiled if

being used for drinking, cooking, making ice, brushing teeth, or washing dishes. Water should be brought to a rolling boil for at least one minute, officials say, and bottled water can be used as an alterna-

The notice is effective immediately and will be in effect for at least two days after tests are passed.
