TITLE: Ordinance Amending Chapter 28 of the City's Code of Ordinances for
Increases to Wastewater Rates, Tapping Charges, Water Rates, Master
Meter Charges, Service Availability Charges, Sprinkling Charges, Fire
Service Charges, and the Repeal of the Annual Rebate Test –
(Commission Districts 1, 2, 3 and 4)

Recommendation

It is recommended that the City Commission approve on first reading an Ordinance amending Sections 28-76, 28-141, 28-143, 28-144 and 28-145 of the City's Code of Ordinances, to provide for alignment of charges for fiscal year 2020 to water and sewer cost of services, and to provide for increases to water and wastewater rates, tapping charges, master meter charges, sprinkling charges, fire service charges, and service availability charges, to allow payback terms for tapping charges for installation of sprinkling meters, and to repeal the annual rebate test identified in Note 1 at Section 28-76 (b)(1).

Background

In April 2018, Stantec Consulting Services Inc. (Stantec) was awarded a contract to perform a Water & Wastewater Comprehensive Rate Study (Study) to evaluate the current and projected financial performance of the City's Water and Sewer Enterprise Fund, evaluate the rate structure and identify rate revenue adjustments that will provide for a financially sustainable future. The financial sustainability analysis ensures that the Fund can meet all of its ongoing obligations such as budgeted operating expenses, budgeted capital improvements, existing debt service and minimum reserve targets with its current income level, or if necessary, identifies additional revenue levels required for the fund to be sustainable.

This Amendment will simplify the current and future water and sewer rate methodology by realigning the water and sewer rates to the City's respective water and sewer cost of services, reducing the number of tiers (formerly identified as blocks), and allow for rate increases to wastewater user rates, tapping charges, water rates, sprinkling meter

charges, private fire service protection charges, and service availability charges in order to generate necessary funds for present and future needs, water main replacement, sewer rehabilitation, administration, operation and long-range projects under the Water and Sewer Master Plan. The new rate structure is designed to be revenue neutral for FY 2020.

**Water and Sewer Charges
Effect of Monthly Increase on Neighbors**

(Example is based on a common residential meter and an average usage of 5,000 gallons/month)

5/8 Inch Meter	Current Rate	Proposed Rate	\$ Change	% Change
Total	\$66.27	\$67.13	\$0.86	1%

Additionally, the amendment will smooth the costs of tapping charges for residential accounts installing a secondary meter for irrigation purposes. For tapping fee payments, each customer may experience different payment periods dependent on their usage levels, sprinkling meter size, and the full cost of installation. Based on billing data used in the Study, most residential customers that choose to install a sprinkling meter have significant outdoor usage, which will allow tapping fees to be paid in interest-free installments for a period of up to 18 months. These payment periods are in alignment with other South Florida municipalities.

Lastly, the repeal of the provision in the Ordinance that provides for rebates based on the annual test will assist the City in raising cash reserves to fund future projects and reduce the cost of issuing bonds to fund replacement and rehabilitation of the water and sewer system.

Resource Impact

The new rate structure is designed to be revenue neutral for FY 2020.
