

RESOLUTION NO. 24-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, DENYING THE APPLICATION BY WALLACE DAVID WILLIFORD AND TRACEY TERRELL WILLIFORD, HUSBAND AND WIFE, OF A PROPOSED 45'+/- LONG X 8'+/- WIDE MARGINAL DOCK, TWO (2) MOORING PILES, AND APPURTENANT ACCESS STEPS EXTENDING A MAXIMUM DISTANCE OF 25'+/- FROM THE SEAWALL WETFACE FOR CORDOVA ROAD ABUTTING THE WATERS ADJACENT TO 1025 CORDOVA ROAD, PURSUANT TO SECTION 8-144 OF THE CODE OF ORDINANCES OF THE CITY OF FORT LAUDERDALE.

WHEREAS, Section 8-144 of the Code of Ordinances of the City of Fort Lauderdale, Florida, provides that the City Commission may grant a dock permit; and

WHEREAS, Wallace David Williford and Tracey Terrell Williford, Husband and Wife (hereinafter "Applicant"), owns the Property located at 1025 Cordova Road, Fort Lauderdale, Florida, 33316, Broward County Property Appraiser's Parcel ID# 5042 11 18 1900 (hereinafter "Property"); and

WHEREAS, Applicant applied for a permit to install, use, maintain and repair a proposed 45'+/- long x 8'+/- wide marginal dock, two (2) mooring piles, and appurtenant access steps extending a maximum distance of 25'+/- from the seawall wetface for Cordova Road on public property abutting the waters adjacent to 1025 Cordova Road (hereinafter "Application").

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That each WHEREAS clause set forth above is true and correct and incorporated herein by this reference.

SECTION 2. That the City Commission of the City of Fort Lauderdale, Florida, after reviewing and weighing the documentary evidence and testimony of those addressing the Commission at its Regular Meeting of May 7, 2024, as to the Application for a permit to install, use, maintain and repair a proposed 45'+/- long x 8'+/- wide marginal dock, two (2) mooring piles, and appurtenant access steps extending a maximum distance of 25'+/- from the seawall wetface for Cordova Road on public property abutting the waters adjacent to 1025 Cordova Road, and same is hereby denied.

SECTION 3. That this Resolution shall be in full force and effect upon final adoption.
