Projects, in the amount of \$75,000.00, no match required.

Recommendation

It is recommended that the City Commission approve a motion authorizing the proper City officials to accept a grant from the United States Department of Homeland Security and the State of Florida Division of Emergency Management and to execute any documents required to accept funds between the City of Miami and the City of Fort Lauderdale.

Background

The United States Department of Homeland Security (USDHS) has provided financial assistance to the Miami urban area in the amount of \$ 9,356.839 through the FY 2011 Miami and Fort Lauderdale collectively. The sponsoring and coordinating agency is the City of Miami, via memorandum of agreement.

The City of Fort Lauderdale has received a sub-grant in the amount of \$ 75,000.00 with no required match. Funds will be used towards enhancement of Citizen Corps programs, Citizen Corps Regional Conference (\$ 29,000.00), Regional Citizen Corps equipment (\$ 25,000.00), Citizen Corps uniforms (\$ 13,000.00) and trainings/drills (\$8,000.00).

There is a positive fiscal impact to the City in the amount of \$75,000.00.
