TITLE:	Motion to approve the purchase of information technology consulting services - \$195,000

## **Recommendation**

It is recommended that the City Commission approve the purchase of information technology consulting services, via the State of Florida contract #973-561-10-1, from TEKsystems Inc. for an annual amount estimated not to exceed \$195,000.

## **Background**

The Information Technology Services (ITS) Department has several vacant positions. With technology in such high demand, it has become difficult to retain quality technical staff. The ITS Department has many projects in progress with key timelines that will be impacted without quality technical staff to assist with the work.

The ITS Department has already purchased services from TEKsystems to temporarily fill two vacant positions for staff working on the city-wide telephone system upgrade (as well as the day to day management of the network and Internet). TEKsystems was issued a purchase order for \$49,199. In order to continue using their staff augmentation services in excess of \$50,000, City Commission approval is required.

A currently vacant position from the Geographic Information Systems (GIS) group is responsible for developing and maintaining in-house GIS web applications; additional staffing services would be utilized to assist with that work, which includes key projects associated with the Department of Sustainable Development's OneSolution software upgrade project.

Staff recommends purchasing information consulting services from TEKsystems to provide continuing assistance for the city-wide telephone systems upgrade, GIS web applications, and special projects as well as to assist with other workloads impacted by vacancies.

## Resource Impact

There is a fiscal impact to the City in the amount of \$195,000.
