

**AMENDMENT TO AGREEMENT  
FOR CENTRAL CITY REZONING CONSULTANT**

**THIS AMENDMENT TO AGREEMENT**, made this 8<sup>th</sup> day of February 2019, by and between the **Fort Lauderdale Community Redevelopment Agency**, a community redevelopment agency created pursuant to Part III, Chapter 163, Florida Statutes, ("CRA"), whose address is 100 North Andrews Avenue, Fort Lauderdale, FL 33301-1016, and **The Mellgren Planning Group Inc.**, a Florida corporation, ("Contractor" or "Company") whose address and phone number are 3350 NW 53<sup>rd</sup> Street, Suite 101, Fort Lauderdale, Florida 33309, Phone: 954-475-3070, Email: Michele@floridaplanning.net.

WHEREAS, the CRA and Contractor entered into an Agreement for Central City Rezoning Consultant pursuant to RFP No. 575-11935, dated November 2, 2017 ("Agreement"); and

WHEREAS, the CRA and Contractor wish to amend the Agreement by correcting the title of the agreement and increasing the workload by 103 hours distributed between Task C, Task D2 and Task G, thereby increasing the total contract amount by \$14,000;

NOW THEREFORE, for and in consideration of the mutual promises and covenants set forth herein and other good and valuable consideration, the CRA and the Contractor agree to amend the Agreement as follows:

1. Remove word "TRI-PARTY" from the title.
2. Increase Task C by 16 hours.
3. Increase Task D2 by 57 hours.
4. Increase Task G by 30 hours.
5. All other terms and provisions of the original Agreement between the parties shall remain in full force and effect.

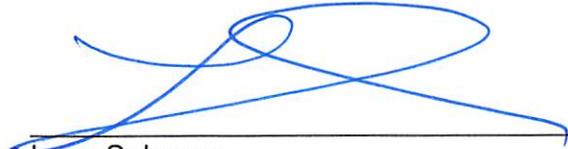

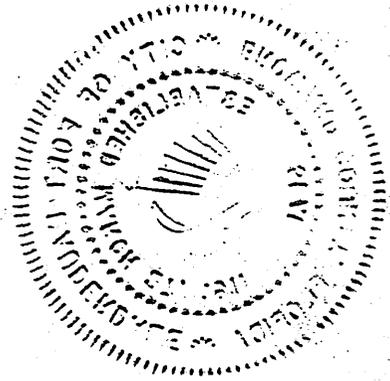

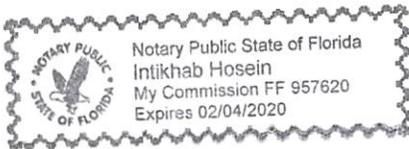
