TITLE: Motion Approving Contract for Coontie Hatchee Canoe Launch Project -
Sagaris Corp. – \$530,100 – **(District 4)**

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for the Coontie Hatchee Canoe Launch Project No. 12201 with Sagaris Corp. in the amount of \$530,100.

Background

The Coontie Hatchee Canoe Launch Project (Project) was originally solicited via Invitation to Bid No. 12234-293. Three bids were received in response but all had wide unit pricing swings, as each bidder considered numerous line items differently. As such, all bids were rejected (CAM #19-0397) and it was determined that the project would be rebid. The scope of work for Project includes, but is not limited to, the demolition of an approximately 49-foot section of existing seawall, the construction of a sandy beach for canoe launch and mangrove island, new site pole lights, and additional landscaping.

On July 17, 2019, the Procurement Services Division issued Invitation to Bid No. 12318-293 to solicit competitive bids. A total of five bids were received on August 9, 2019 from the following vendors:

- Sagaris Corp.
- Johnson-Laux Construction
- Interstate Construction LLC
- Poseidon Dredge & Marine
- Shoreline Foundation Inc.

Three of the five vendors that responded are either a Minority Owned Business Enterprise, Women Owned Business Enterprise, or Small Business Enterprise. All of the bids were reviewed for compliance with the solicitation specifications. The bid submitted by Sagaris Corp. has met all the specifications of the solicitation and has been deemed the lowest cost, responsive, and responsible bid. Staff recommends awarding the contract to the lowest responsive and responsible bidder, Sagaris Corp. References checks for Sagaris Corp. were all in compliance with City standards.

Resource Impact

There will be a fiscal impact in the amount of \$530,100 for the contract award with the allowances included and \$6,515 for estimated in-house project management fees for a total of \$536,615. Funds for this item are available in the FY 2019 Community Investment Plan in the account listed below:
