TITLE: Motion Approving Agreements for Annual Traffic and Transportation Engineering and Planning Services – Various Contractors - \$5,100,000.00 - (Commission Districts 1, 2, 3 and 4)

### **Recommendation**

Staff recommends the City Commission approve five (5) two-year agreements, in substantially the forms attached, with Kimley-Horn and Associates, Inc. (Kimley-Horn), Kittelson & Associates, Inc (Kittelson), Tindale-Oliver & Associates, Inc (Tindale Oliver), The Corradino Group, Inc. (Corradino) and Marlin Engineering, Inc. (Marlin) for Annual Traffic and Transportation Engineering and Planning Services, in the estimated aggregate amount of \$5,100,000.00 for the initial two-year term, and authorize the City Manager to approve three (3) one-year renewal options contingent upon appropriation of funds.

### **Background**

January 19, 2020, a Request for Qualifications (RFQ) 12370-206 was issued for Annual Traffic and Transportation Engineering and Planning Services. Nine (9) qualified submittals were received by the advertised deadline to an RFQ (Exhibit 1), to provide Professional Traffic and Transportation Engineering Services under a continuing services contract. The list of respondents is attached (Exhibit 2). Two of the nine vendors indicated that they were a Minority Owned Business Enterprise, Women Owned Business Enterprise, or Small Business Enterprise.

The Evaluation Selection Committee consisted of the following City staff members: Jeff Davis, Parking Services Manager; Karen Warfel, Transportation Planning Manager; and Lisa Marie Glover, Transportation Manager

On June 26, 2020, the Committee evaluated and ranked submittals in accordance with pre-established rating criteria and short-listed the respondents to seven (7) firms. The firms were ranked based on the evaluation criteria shown in the table below.

The short-listed firms provided presentations and were interviewed by the Committee on August 6, 2020 and August 7, 2020. The top seven firms selected for presentations were Calvin, Giordano & Associates, Inc; Kimley-Horn; Kittelson; Tindale Oliver; Alta; Corradino; and Marlin. The Committee's tabulation is attached (Exhibit 3).

August 7, 2020, the Committee met to evaluate the presentations of the selected firms. The firms' presentations were ranked based on the evaluation criteria shown in the table above. Upon careful consideration, the Committee decided to select the top 5 firms to enter contract negotiations. Negotiations failed with the 4<sup>th</sup> ranked firm, Alta. In accordance with options offered under the Florida Consultants' Competitive Negotiations Act statute, when negotiations fail with one firm, those negotiations must be terminated, and negotiations may be held with the next most qualified firm. The next qualified firm, in accordance with the committee ratings, was Corradino.

All negotiations have been completed and staff is requesting approval to formally terminate the negotiations with Alta, and award agreements with the following firms: Marlin; Tindale Oliver; Kimley-Horn; Corradino; and Kittelson.

### **Resource Impact**

There will be a fiscal impact to the City of \$5,100,000, over the initial two-year contract term with an optional three (3) one-year renewal options contingent upon appropriation of funds. For the current first fiscal year, there is appropriated amount of \$2,246,788 as shown in the accounts below.
