

ORDINANCE NO. C-21-36

AN ORDINANCE OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING SCHEDULE VI, SPECIAL EMPLOYEES, OF THE PAY PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, BY INCREASING THE HOURLY MINIMUM WAGE OF CERTAIN PAY RANGES CONSISTENT WITH THE STATE OF FLORIDA MINIMUM WAGE, AND PROVIDING FOR SEVERABILITY, REPEAL OF CONFLICTING ORDINANCE PROVISIONS, AND AN EFFECTIVE DATE.

WHEREAS, Article X, Section 24 of the Constitution of the State of Florida provides for the minimum wage for all hours worked in Florida to be \$10.00 per hour effective September 30, 2021, and to increase each September 30 thereafter by \$1.00 per hour until the minimum wage reaches \$15.00 per hour on September 30, 2026; and

WHEREAS, the City Manager and the Director of Human Resources propose amending Schedule VI, Special Employees, of the Pay Plan of the City of Fort Lauderdale, Florida, by increasing the minimum wage consistent with the State of Florida minimum wage;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That, effective September 30, 2021, Exhibit 4 to Ordinance No. C-21-30, to wit, Schedule VI, Special Employees, of the Pay Plan of the City of Fort Lauderdale, Florida, attached hereto as Exhibit 1, is hereby replaced by a revised Schedule VI, which is attached hereto as Exhibit 2 and incorporated herein, thereby increasing the hourly minimum wage of any pay range that was theretofore below \$10.00 per hour to \$10.00 per hour.

SECTION 2. That, effective September 30, 2022, the hourly minimum wage of any pay range set forth in Schedule VI of the Pay Plan of the City of Fort Lauderdale, Florida, that was theretofore below \$11.00 per hour shall be increased to \$11.00 per hour.

SECTION 3. That, effective September 30, 2023, the hourly minimum wage of any pay range set forth in Schedule VI of the Pay Plan of the City of Fort Lauderdale, Florida, that was theretofore below \$12.00 per hour shall be increased to \$12.00 per hour.

SECTION 4. That, effective September 30, 2024, the hourly minimum wage of any pay range set forth in Schedule VI of the Pay Plan of the City of Fort Lauderdale, Florida, that was theretofore below \$13.00 per hour shall be increased to \$13.00 per hour.

SECTION 5. That, effective September 30, 2025, the hourly minimum wage of any pay range set forth in Schedule VI of the Pay Plan of the City of Fort Lauderdale, Florida, that was theretofore below \$14.00 per hour shall be increased to \$14.00 per hour.


SECTION 6. That, effective September 30, 2026, the hourly minimum wage of any pay range set forth in Schedule VI of the Pay Plan of the City of Fort Lauderdale, Florida, that was theretofore below \$15.00 per hour shall be increased to \$15.00 per hour.

SECTION 7. That if any clause, section, or other part of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.

SECTION 8. That all ordinances or parts of ordinances in conflict herewith, be and the same are hereby repealed, except that this Ordinance does not repeal the one and one-half percent general wage increase for Schedule VI special employees effective October 3, 2021, as provided in Ordinance C-21-30, and set forth in Exhibit 3, which is attached hereto and incorporated herein, and which replaces Exhibit 2.

SECTION 9. That, except as otherwise provided herein, this Ordinance shall be in full force and effect upon final passage.
