PROVIDE COST SHARE SUPPORT FOR THE C-12/C-13 INTERCONNECT PROJECT FOR PROVIDING INCREASED WATER CONSERVATION, RECHARGE OF THE C-12 CANAL AND IMPROVED WATER QUALITY IN THE NORTH FORK OF THE NEW RIVER

This is a Third Amendment to that certain Agreement between: BROWARD COUNTY, a political subdivision of the state of Florida, hereinafter referred to as "COUNTY."

AND

CITY OF FORT LAUDERDALE, an independent political subdivision of the State of Florida, hereinafter referred to as "CITY."

WHEREAS, COUNTY and CITY entered into an Interlocal Agreement which was approved by COUNTY on April 27th, 2010, and amended on December 6, 2011, and on March 28, 2013 providing for water conservation and improvements to the conveyance and management of surface waters for Integrated Water Resource Plan (IWRP) related projects which will improve the effective and efficient use of local water resources; and

WHEREAS, the parties are desirous of amending the terms of the agreement to provide for an extension of time with no changes in funding from COUNTY or CITY. The amendment is therefore deemed a no-cost amendment to the Agreement;

NOW, THEREFORE, in consideration of the mutual terms and conditions, promises, covenants and payments hereinafter set forth, COUNTY and CITY agree as follows:

- 1. The above recitals and representations are true and correct and are incorporated herein.
- 2. Article 4, Term and Time of Performance of Agreement, Section 4.1 is hereby amended as follows:
 - 4.1 This Agreement shall become effective upon execution by COUNTY and CITY and shall continue in full force and effect until midnight, on December 31, 2015. In addition, the County Administrator is authorized to execute any amendments extending the term of this Agreement with the appropriate amendment prepared with the same or similar formality.
- 3. Exhibit A, SCOPE OF WORK, C-12/C-13 Interconnect Project, is hereby amended as follows:

Project Schedule and Deliverables:

The project will be completed according to the following timeframe:

Project Design – Complete in February 2010

Permitting – Complete in April 2012

Construction – Complete in October 2012

December 2013

4. Except as amended herein, all other terms and conditions of the Agreement, as incorporated herein, shall remain in full force and effect.


