A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, VACATING ALL OF THAT CERTAIN EASEMENT NUMBER 964 RECORDED IN OFFICIAL RECORDS BOOK 4593, PAGE 602 OF THE PUBLIC RECORDS OF BROWARD COUNTY DESCRIBED AS A PORTION OF LOT 25, BLOCK A, "CITRUS PARK FARMS", ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 1, PAGE 138 OF THE PUBLIC RECORDS OF DADE COUNTY, FLORIDA, LOCATED WEST OF NORTHWEST 13<sup>TH</sup> AVENUE, SOUTH OF NORTHWEST 8<sup>TH</sup> STREET, EAST OF NORTHWEST 13<sup>TH</sup> TERRACE AND NORTH OF NORTHWEST 7<sup>TH</sup> STREET, LYING AND BEING IN THE CITY OF FORT LAUDERDALE, BROWARD COUNTY, FLORIDA.

WHEREAS, the City Engineer has certified that there is no objection to the vacation; and

WHEREAS, the Department of Sustainable Development has made the required reports and has also recommended the vacation of the easement, certifying that the same will not be required to serve the property;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the below described easement is hereby vacated and shall no longer constitute an easement for sanitary sewer pipes:

SECTION 3. That this Resolution shall take effect immediately upon its adoption.
