RESOLUTION NO. 12-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA ACCEPTING A GRANT FROM THE FLORIDA INLAND NAVIGATION DISTRICT IN THE AMOUNT OF \$876,906 FOR IMPROVEMENTS TO THE SE 15TH STREET BOAT LAUNCH AND MARINE COMPLEX; AUTHORIZING EXECUTION A FLORIDA INLAND NAVIGATION DISTRICT PROJECT AGREEMENT BY THE CITY MANAGER; AMENDING THE FINAL OPERATING BUDGET OF THE CITY OF FORT LAUDERDALE, FLORIDA, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2012, AND ENDING SEPTEMBER 30, 2013.

WHEREAS, Resolution 12-61, adopted March 20, 2012 authorized the City Manager to apply for grant funding from the Florida Inland Navigation District; and

WHEREAS, staff submitted an application to the Florida Inland Navigation District ("FIND") for a \$876,906 grant with matching funds in the amount of \$371,211 for improvements to the S.E. 15th Street Boat Launch and Marine Complex; and

WHEREAS, the CITY must execute a FIND Project Agreement and acceptance of the grant funds needs to be appropriated within the Final Operating Budget for the Fiscal Year beginning October 1, 2012;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1.</u> That the City Commission hereby authorizes acceptance of the \$876,906 grant from FIND and further authorizes execution of the FIND Project Agreement by the City Manager on behalf of the City.

<u>SECTION 2</u>. That the City Commission of the City of Fort Lauderdale does hereby support matching funds of \$371,211 for this grant program and authorizes the City Manager to execute the necessary documents to receive and disburse funds.

<u>SECTION 3.</u> That the 2013 Fiscal Year Final Operating Budget is hereby amended by appropriating Florida Inland Navigation District grant funds in the amount of \$876,906.00 for the S.E. 15th Street Boat Launch and Marine Complex redevelopment Project P 11422 as more particularly set forth below:
