**TITLE**: Resolution Approving a Public Transportation Grant Agreement with the

Florida Department of Transportation for Design and Construction of FXE Taxiway Bravo & Quebec Realignment Project at Fort Lauderdale

Executive Airport - \$1,633,600 - (Commission District 1)

## **Recommendation**

Staff recommends the City Commission adopt a resolution approving a Public Transportation Grant Agreement (PTGA) and accepting the anticipated grant funding of up to \$1,633,600 for Design and Construction of FXE Taxiway Bravo & Quebec Realignment Project from the Florida Department of Transportation (FDOT) at Fort Lauderdale Executive Airport (FXE) and authorize the City Manager to execute a Public Transportation Grant Agreement.

## **Background**

The project aims to realign existing Taxiway Bravo and Quebec at FXE. Currently, aircraft holding short of Runway 9-27 on Taxiways Foxtrot and Bravo are located inside the Runway 13 Runway Protection Zone (RPZ). The re-alignment of Taxiway Bravo and Quebec will allow aircraft to remain clear of this area. In addition, Taxiway Quebec will be constructed perpendicular as recommended in the latest Federal Aviation Administration (FAA) design circular.

The scope of project will include the removal of existing Taxiways and re-constructed as perpendicular Taxiways to Runway 9-27 to conform to current FAA design standards. New LED taxiway edge lights and guidance signs will be installed, as well as in-ground and elevated Runway Guard Light units at the hold-short lines. The Airport Lighting Control Monitoring (ALCM) system will also be modified with the new taxiway configuration (Exhibit 1).

With an estimated design and construction cost of \$2,042,000, FDOT is providing a Public Transportation Grant Agreement in the amount of \$1,633,600 for up to 80% of the projected costs, and the Airport will provide a 20% match in the amount of \$408,400, which is contingent upon approval of the February 7, 2023, Consolidated Budget CAM 23-0085.

At its meeting of December 1, 2022, the Aviation Advisory Board supported staff's recommendation to accept this grant from FDOT.

## **Resource Impact**

There is an anticipated positive fiscal impact to the City for the grant in the amount of \$1,633,600 and a grant match in the amount of \$408,400. An additional \$71,470 in project management and engineering fees will be provided from the Airport fund. These appropriations are contingent upon the approval of the February 7, 2023, Consolidated Budget Amendment CAM 23-0085.
