TITLE: Motion Approving a Service Agreement with DJ The Artiste LLC for a Mural
at Mills Pond Park - \$8,160 - **(Commission District 3)**

Recommendation

Staff recommends the City Commission approve a service agreement with DJ The Artiste LLC, in substantially the form attached, for the artistic design, materials, and workmanship of a Mural that will display on the reverse side of the Mills Pond Park sign which currently faces I-95 expressway and authorize the City Manager to execute the agreement.

Background

The Parks and Recreation Department has been working with artist Djerlens Chery to create a mural at Mills Pond Park. The sign is located at the back of Mills Pond Park near the lake which faces I-95 expressway. The mural will present an opportunity for highly visible and vibrant artwork that displays random images of sports figures from the various sports offered at Mills Pond Park.

The Mills Pond Park Mural Proposal was presented to the Public Art & Placement Advisory Board on December 21, 2022. After a discussion on the project, the Public Art & Placement Advisory Board approved the project by a unanimous 5 to 0 vote.
