City Clerk Modarelli explained that following a vote on the Affordable Housing Advisory Committee (AHAC) Ordinance included on this Agenda, a Commission Member would need to be appointed to the AHAC. The term would begin September 25, 2020 and end September 24, 2023. Mayor Trantalis confirmed his willingness to serve on the AHAC.

Commissioner McKinzie introduced this Resolution as amended which was read by title only.

Mayor Trantalis recognized Philip Gonot, 2598 East Sunrise Boulevard and PMG Consultant. Mr. Gonot confirmed his availability to answer questions related to this item.

Vice Mayor Glassman discussed financial details related to the City's only Historic District, *Sailboat Bend Historic District*. He expounded on concerns regarding *Historic Preservation Development Application Fees (Fees)* imposed on residents who wish to alter their properties. He commented on the process and related details.

Vice Mayor Glassman explained his perspective on providing financial

relief to residents mandated to come before the *Historic Preservation Board* and pay *Fees* in addition to associated expenses, i.e., copies, etc. Comment and discussion ensued. Mayor Trantalis commented on his perspective regarding covering administrative costs.

In response to Vice Mayor Glassman's question, Anthony Fajardo, Department of Sustainable Development Director, explained *Fees* listed are one-half of full cost recovery for related Staff work. He expounded on utilizing the same methodology in a related 2008 Resolution. Mr. Fajardo confirmed *Sailboat Bend* is the only Historic residential neighborhood in the City subject to these *Fees*. Further comment ensued.

Commissioner Sorensen suggested modifying the Resolution. Vice Mayor Glassman explained related details. Further comment and discussion ensued.

Commissioner McKinzie concurred with Vice Mayor Glassman's viewpoint, confirming applicants would also be paying a *Building Permit Fee*. Discussion ensued on the process and recovering administrative costs. Mayor Trantalis noted the need for further analysis. Further comment ensued.

Mr. Fajardo said \$7,250 was the amount of *Fees* collected in 2019 for all projects, as noted in *Exhibit 3* of the Commission Agenda Memo. Mr. Gonot confirmed the consultant analysis only addressed *Fees*.

Vice Mayor Glassman reviewed *Fees* and related details listed in *Exhibit* 3, expounding on his perspective. Commissioner McKinzie concurred.

In response to Mr. Fajardo's request for clarification about including designated landmark sites, Vice Mayor Glassman confirmed, requesting additional information. Mr. Fajardo confirmed designated landmark site *Fees* are very low and are only located in *Sailboat Bend*.

Vice Mayor Glassman explained his perspective. Mayor Trantalis explained his perspective regarding *Sailboat Bend* and concerns regarding elimination of *Fees*. Vice Mayor Glassman explained the need for incentives to preserve Historic Designation.

In response to Commissioner Sorensen's question regarding the Sailboat Bend neighborhood wanting additional regulations, Vice Mayor Glassman explained previous neighbor input in favor of it being a *Historic District*, expounding on details related to maintaining incentives and citing examples.

Mr. Fajardo requested clarity. City Attorney Boileau confirmed this Resolution could be amended, eliminating all *Fees*, addressing *Fees* at a later date. City Manager Lagerbloom explained his recommendations. Further comment ensued.

City Manager Lagerbloom recommended the following Fees remain in the Resolution: Designation of Historic District; Designation of Landmarks, Landmark Site or Buildings or Archaeologist Site; Administrative Certification of Appropriateness (COA); After the Fact Administrative (COA); and Archaeology Review.

Commissioner McKinzie introduced this Resolution as amended which was read by title only.

Each Commission member disclosed verbal communications, written communications, site visits and expert opinions received.

Mayor Trantalis opened the public hearing.

Mayor Trantalis recognized Stephanie Toothaker, Esq., on behalf of the applicant, *Brookfield BSREP III Fort Lauderdale LLC*. Ms. Toothaker explained this Resolution addresses approval of the plat known as *Hilton Marina Hotel Plat (Plat)*. A hotel is already built on this site and this Resolution is a clean-up item. Ms. Toothaker said she is available to answer any questions along with Jim McLaughlin.

Mayor Trantalis recognized Robert Kain, 1819 SE 17th Street. Mr. Kain commented on the need for pubic dock access along the *Intracoastal*. He discussed addressing traffic concerns during construction along Grande Drive that leads to the northern area of Eisenhower Avenue north of 17th Street Causeway. Mr. Kain said a proposal addressing traffic concerns had been delayed by the *Broward County Metropolitan Planning Organization (MPO)*. Mr. Kain requested confirmation the building height is four (4) stories and six thousand (6,000) square footage for commercial space.

In response to Mayor Trantalis' question, City Attorney Boileau confirmed this Resolution only addresses the *Plat*. Mayor Trantalis informed Mr. Kain this item only addresses the *Plat* because a plat was never done for the existing building.

Mayor Trantalis noted dockage discussed by Mr. Kain has public access and is rented.

Ms. Toothaker explained the site plan for the related project is a *Site Plan Level III (Site Plan)* and was approved by the *Planning and Zoning (P&Z) Board* in November 2019 and would not be coming before the Commission.

In response to Mayor Trantalis' request, Ms. Toothaker confirmed Mr. Kain could contact her and address his questions. Commissioner Sorensen confirmed he would provide Ms. Toothaker's contact information.

There being no one else wishing to speak on this item, Vice Mayor Glassman made a motion to close the public hearing which was seconded by Commissioner McKinzie. Mayor Trantalis recognized Stephanie Toothaker, Esq., on behalf of the applicant *KT Seabreeze Atlantic, LP (Applicant)*. Ms. Toothaker introduced team members. Ms. Toothaker and team members were sworn in by City Clerk Jeffrey Modarelli.

Ms. Toothaker narrated the development project presentation, outlining the *Original Site Plan* and opportunities and modifications made to the revised *Planned Development District (PDD) Site Plan* and related rezoning *(PDD Development Project)*.

Ms. Toothaker said Staff had done a complete analysis of rezoning criteria and determined rezoning criteria had been met.

Each of the following speakers were sworn in by City Clerk Jeffrey Modarelli.

Mayor Trantalis recognized James R. Novick, 209 North Birch Road, President of the *Alhambra Place Association*. Mr. Novick noted the significant impact of this development on *Alhambra Place Condominium*. He confirmed support of the Development Project, explaining details that improve the community.

Mayor Trantalis recognized William Brown, President of the *Central Beach Alliance (CBA)*. Mr. Brown discussed Ms. Toothaker's presentations to the *CBA*, including the *Original Site Plan* and the *PDD Development Project*. He expounded on the impact of COVID limiting *CBA* participation. There were (2) public participation meetings regarding the *PDD Development Project*. There was a virtual *CBA* meeting in July 2020, with limited participation during summer months. He noted there were sixty-seven (67) votes in opposition and nineteen (19) in support of the *PDD Development Project*. Mr. Brown discussed aspects of the *CBA* vote in opposition. Subsequently, Ms. Toothaker and the *Applicant* met with adjacent condominiums to the *PDD Development Project* addressing concerns. He commented on his perspective regarding the CBA vote and other details. Mr. Brown confirmed his support of the *PDD Development Project*.

Mayor Trantalis recognized Chad McCoury, 112 N. Birch Road,

President of Wedgewood Court Condominium Association (Wedgewood). Mr. McCoury explained the location of Wedgewood in relation to the PDD Development Project, commenting on discussions with Ms. Toothaker related to construction concerns. Mayor Trantalis confirmed the need for the Applicant to ensure roadways remain open and the impact of other construction concerns are minimal. Ms. Toothaker confirmed, expounding on related details.

Ms. Toothaker thanked all stakeholders, Vice Mayor Glassman and the Commission for their input and support.

There being no one else wishing to speak on this item, Commissioner McKinzie made a motion to close the public hearing which was seconded by Commissioner Sorensen. Roll call showed: AYES: Vice Mayor Glassman, Commissioner McKinzie, Commissioner Sorensen, Commissioner Moraitis and Mayor Trantalis. NAYS: None.

## **CITY MANAGER REPORT**

City Manager Lagerbloom updated the Commission on Fiscal Year

2021 (FY 2021) Budget negotiations with Collective Bargaining Units regarding the delayed participation in the Florida Retirement System (FRS) and a freeze on the one point five percent (1.5%) Cost of Living Adjustment (COLA).

The Fraternal Order of Police (FOP) and International Association of Fire Fighters (IAFF) agreed to forgo the COLA and delay FRS participation. The Teamsters Local Union 769 (Teamsters) and Federation of Public Employees (Federation) have not agreed to these two (2) negotiating points, resulting in a FY 2021 Budget shortfall.

City Manager Lagerbloom commented on the ability to address this *FY 2021* shortfall in other areas of the *Teamsters* and *Federation* contracts, noting possible union member outreach to the Commission. City Manager Lagerbloom advised the Commission to refer any communications on this subject back to the respective bargaining agent. He confirmed union negotiations would continue.

Commissioner Sorensen recognized the upcoming retirement of Chaz Adams, Strategic Communications Division Manager. Mayor Trantalis, Commission Members and City Manager Lagerbloom acknowledged and commented on the outstanding, lengthy duration of Mr. Adams' service.
