The City shall maintain at its own expense and keep in effect during the full term of the Agreement, self-insurance under a Risk Management Program in accordance with Florida Statutes, § 768.28 for General Liability and Auto Liability, and Workers' Compensation, including Employer's Liability (with benefits in accordance with Chapter 440 Florida Statutes) coverage. The City will provide a letter of self-insurance for general and auto liability as prescribed under § 768.28 Florida Statutes.

The City will be solely responsible for loss of City owned improvements, betterments, furnishings, fixtures, and other business
personal property situated in or about the Premises to the full replacement value of the property.

(Hereinafter referred to as "EVENT") in the Broward Center for the Performing Arts, located at 201 Southwest Fifth Avenue, Fort Lauderdale, Florida. PACA and LICENSEE mutually agree to:

- 1. **FEES:** For licensing of the premises, LICENSEE agrees to pay PACA the above fees and charges.. If LICENSEE is not responsible for Sales and Use Tax, All rental fees outlined in the LICENSEE column, setup fees, display fees and damage deposit are due at the signing of this lease agreement.
- 2. ENTIRE AGREEMENT: This Agreement, including the Terms and Conditions addendum attached or any other addendum attached or referred to, contains the entire understanding of the parties and there are no other agreements or understandings, written or oral, with respect to this license agreement and this agreement may not be changed or altered, except in writing and signed by both parties. This Agreement shall be constructed and interpreted in accordance with the laws of the State of Florida. The venue for any proceedings shall be in Broward County, Florida. Any and all differences, disputes or controversies arising out of or in connection with this Agreement shall be settled by arbitration before a single arbitrator in the state of Florida in accordance with the rules then obtaining of the American Arbitration Association and judgment upon the award rendered may be entered in any Court having jurisdiction thereof.
- 3. SCHEDULING AND DATE CHANGES: The dates identified in *Attachment A* are subject to change upon approval by the City Commission. The City agrees to provide the Performing Arts Center Authority ("PACA") with reasonable advance written notice of any such changes. The City acknowledges that any modifications to the scheduled dates are subject to room availability and may require mutual coordination between the City and PACA to secure alternate dates.
- 4. PAYMENT OBLIGATION: The City shall be responsible for payment on an event-by-event basis only. The City's financial obligation is limited to fees associated with its actual use of the premises. The City shall not be required to remit full rental amounts upfront, nor shall the City be obligated to pay for dates, times, or services not utilized, provided that sufficient notice is given. However, if PACA has incurred any out-of-pocket expenses in connection with a scheduled event that the City subsequently cancels, the City shall remain responsible for reimbursing such expenses.
