

RESOLUTION NO. 22-131

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, SUPPORTING THE HONORARY DESIGNATION OF THAT PORTION OF S.R. A1A BETWEEN THE NORTHERN TERMINUS AND SOUTHERN TERMINUS OF GALT OCEAN DRIVE IN THE CITY OF FORT LAUDERDALE, FLORIDA, AS "PIO IERACI MEMORIAL DRIVE," AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Subsection (10) of Version S 160 er of Senate Bill 160 in the 2022 Florida Legislature, which was signed into law on May 9, 2022, and becomes effective on July 1, 2022, provides that "[t]hat portion of S.R. A1A between the northern terminus and southern terminus of Galt Ocean Drive in Broward County is designated as "Pio Ieraci Memorial Drive."; and

WHEREAS, according to the Florida Senate's Bill Analysis and Fiscal Impact Statement for Committee Substitute for Senate Bill 160 prepared by the professional staff of the Committee on Transportation, citing "Dignity Memorial, Pio Richard Ieraci Obituary, available at <https://www.dignitymemorial.com/obituaries/fort-lauderdale-fl/pio-ieraci-9961464> (last visited January 12, 2022),"

Pio Ieraci was born in Windsor, Ontario, Canada and lived in Florida for over 30 years, finding professional success and becoming an active civic leader in Broward County. He was appointed to the City of Fort Lauderdale Education Advisory Board, served as the Chairman of the South Florida Business Advisors, Inc., and of the Broward Beach Coalition, and was instrumental in beach renourishment efforts. He also served as Chairman of the President's Council and the Galt Mile Community Association, as well as serving as the President of the Galt Ocean Club Condominium Association for over 20 years. Mr. Ieraci passed away at the age of 58 and was survived by his mother, Marcy; his wife, Lisa; his son and daughter, Daniel and Alessia, and other extended family and friends.;

WHEREAS, Subsection 334.071(3), Florida Statutes (2021), provides, in part, that "[e]rection of markers shall be contingent on the appropriate city or county commission passing a resolution in support of the particular honorary designation."; and


WHEREAS, that portion of S.R. A1A between the northern terminus and southern terminus of Galt Ocean Drive in Broward County is located within the corporate limits of the City of Fort Lauderdale;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Commission supports the honorary designation of "[t]hat portion of S.R. A1A between the northern terminus and southern terminus of Galt Ocean Drive in Broward County as "Pio leraci Memorial Drive."


SECTION 2. That this Resolution shall be in full force and effect upon final passage.
