

**NOTICE OF PUBLIC HEARING

**Establishing Aeronautical Minimum Annual Lease Rates and Adopting a
Brokerage Commission Policy at Fort Lauderdale Executive**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, CALLING FOR A PUBLIC HEARING ON TUESDAY, OCTOBER 23, 2018 AT 6:00 P.M., FOR THE PURPOSES OF ESTABLISHING AERONAUTICAL MINIMUM ANNUAL LEASE RATES AND ADOPTING A BROKERAGE COMMISSION POLICY FOR PROPERTY AVAILABLE FOR LEASE AT FORT LAUDERDALE EXECUTIVE AIRPORT.

WHEREAS, Section 8.10 of the City Charter provides that the City Commission shall hold a public hearing at least every three years to review and establish the minimum acceptable annual rental rates and top adopt a brokerage commission policy for property available for lease at Fort Lauderdale Executive Airport.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Commission does hereby call a public hearing to be held in the City Commission Room, City Hall, First Floor, 100 N. Andrews Avenue, Fort Lauderdale, Florida, on October 23, 2018 at 6:00 o'clock p.m.
