**TITLE:** Public Hearing – Quasi-Judicial Resolution Approving an After the Fact  
Waiver of Limitations at 100 Hendricks Isle for One (1) Boat Lift Extending  
a Maximum Distance of 31'+/- as Measured from the Property Line into the  
Adjacent Waterway of the Rio Grande Canal - **(Commission District 2)**

---

**Recommendation**

Staff recommends the City Commission adopt a resolution granting an after the fact waiver of limitations for one (1) boat lift at 100 Hendricks Isle.

**Background**

The Unified Land Development Regulations (ULDR) Section 47-19.3(c) limits the maximum distance of mooring structures to twenty-five percent (25%) of the width of the waterway, or twenty-five feet (25'), whichever is less, as measured from the property line. ULDR Section 47-19.3(e) authorizes the City Commission to waive the limitation based on a finding of extraordinary circumstances.

The applicant is seeking a resolution granting an after the fact Waiver of Limitations (a waiver to allow finger piers and mooring piles to extend beyond the maximum distance as defined by City Code) of Section 47-19.3(c) of the Unified Land Development Regulations (ULDR) for one (1) boat lift extending a maximum distance of 31'+/- into the waters of the adjacent Rio Grande Canal as measured from the property line.

The applicant's Summary Description (Exhibit 1) specifies that the extra distance for the boat lift is necessary to facilitate perpendicular dockage and allow safe ingress and egress.

The Marine Advisory Board (MAB) recommended approval (12 – 3) of the application at the November 6, 2025, MAB meeting. Concerns were expressed by several MAB members that this was an After the Fact (ATF) application, as the lifts were installed prior to MAB review.

Per the Code of Ordinances of the City of Fort Lauderdale Section 9-47(a)(1), a double permitting fee penalty is imposed for ATF submissions based on 1.75% of job cost. Once

the ATF permits are submitted, the penalty fee will be assessed in addition to the required \$1,500 application fee.
