The repair list noted removal of tree roots at one of the properties, but he did not see a tree in the swale. Once item O-2 is approved, the City Manager will be authorized to determine where sidewalks will be repaired or where trees will be cut without Commission input. He would like to be able to track repairs. He could not reach the conclusion that it was the City's responsibility to repair all of the items on this particular work order. With respect to District I, Vice-Mayor Roberts pointed out that the City was responsible for damage to some of the sidewalks addressed in this item. Commissioner Rogers supported the item as presented

but wanted to discuss options for tracking repairs in the future.

Commissioner Rogers raised the example pointed out in item M-8. The annual vendor contract of \$750,000 could be spent without the Commission's knowledge. Mayor Seiler noted there are quarterly reports, but he understood the concern. Vice-Mayor Roberts felt that quarterly reports would suffice. Also, the Commission could be copied on correspondence when such repairs are authorized. The purpose of the amendment was to expedite a process that typically takes four to six weeks. During further discussion, Assistant City Manager Susanne Torriente noted that the intent of this ordinance is to work

within the parameters of a contract and budget approved by the Commission. Staff could provide reports more often. The intent is to return to the City Manager's previous authority and to speed up projects. It takes four to six weeks to place an item on a Commission agenda. Commissioner Rogers advised that a sidewalk in his neighborhood has been in disrepair for years and it has been reported to the City. There is a tree in the swale, and it is obvious that the roots damaged the sidewalk. He did not understand why those repairs in the swale were ignored while others were addressed. Therefore, he wanted to know who is making decisions and under what auspices those decisions are being made. It is a question of how work is prioritized. Mayor Seiler was concerned if the Commission has to vote on every sidewalk, the process is no longer streamlined. Vice-Mayor Roberts noted that paving projects are outlined in a five-year plan. The same process is being applied to sidewalks and canal dredging. He was comfortable with tracking via regular reports. Many items are approved in advance with the expectation that staff will execute the work. Commissioner DuBose thought Commissioner Rogers' concerns are valid. He understood that sidewalks are being assessed and prioritized in the same way as pavement. If this is in place, perhaps it would provide a greater comfort level. It currently appears to be somewhat subjective.

Commissioner Rogers said he is comfortable with the trip and fall and utility repair categories.

Public Works Director Hardeep Anand said the sidewalk assessment will be complete in about 60 days. Staff will then make a presentation to the Commission and a score and priority index will be used based on various criteria. The sidewalks will be trackable through the GIS system. Commissioner Rogers explained if there is subjectivity, there needs to be more oversight and accountability. Torriente noted that over the past 2½ years, staff has been trying to look at these matters more strategically and comprehensively. Staff is also looking into a process by which the Commission can review a project list prior to the annual budget approval. The intent is to work within an approved contract and budget. As more pre-planning is done, projects will be executed more quickly. Commissioner Rogers supported that concept but he did not think staff has reached that point with regard to sidewalks. With \$750,000, he wanted more oversight and accountability.

Commissioner Trantalis understood Commissioner Rogers' concern is about projects where there is no strategic plan per se. He raised the idea of the City Auditor ensuring funds are appropriately allocated for their intended purpose. He is comfortable with the ordinance. The City Auditor explained it is difficult to audit subjectivity and determining whether the City Manager's decisions are aligned with policy direction and desires of the Commission because there is no standard to measure against.

At the suggestion of Commissioner DuBose and Mayor Seiler, discussion turned to amending the ordinance. Senior Assistant City Attorney Paul Bangel advised that an ordinance provision is already in place by which the Commission by resolution determines all areas where sidewalks must be constructed and reconstructed. There is also a mechanism for recouping costs under certain circumstances. The second paragraph of the ordinance under discussion could be amended to read, "Notwithstanding the foregoing paragraph, and except as otherwise provided in Section 25-58, the city manager is authorized to approve task orders in amounts that, in the aggregate, do not exceed the contract amount of the corresponding existing contract." That would carve sidewalks out of the ordinance. With the City Attorney's suggestion of using the word "shall," there was agreement on Mayor Seiler's suggestion for the amendment to read, "Notwithstanding the foregoing paragraph, the city manager is authorized to approve task orders in amounts that, in the aggregate, do not exceed the contract amount of the corresponding existing contract and the City Manager shall provide monthly reports to the City Commission on such task orders."

Vice-Mayor Roberts introduced the ordinance as amended, which was read by title only.
