### **Recommendation**

Staff recommends the City Commission approve an agreement, in substantially the form attached, for Invitation to Bid (ITB) Event No. 495-1 – NE 15 Avenue at NE 13 Street Intersection Improvement, with M & M Asphalt Maintenance Inc. d/b/a All County Paving, in the amount of \$113,260.77.

## **Background**

The Broward Metropolitan Planning Organization (BMPO) developed a Complete Streets Master Plan to guide future investments by creating a prioritized list of projects based on technical, data-driven analysis, and community input. The BMPO selected NE 15 Avenue between NE 11 Street and NE 13 Street as one of those projects, and the City added it to its Neighborhood Mobility Masterplan (2015 - 2025).

The BMPO project created a connected community that provides safe multi-modal connections for all users. The project created a business district that encouraged pedestrian-friendly activities and improved safety. The project modified the travel and traffic lane configurations.

Following implementation of the BMPO project, the City received feedback regarding the roadway configuration. As a result, the City has planned to implement additional improvements. As proposed, the improvements are intended to address neighborhood feedback requesting the installation of a dedicated turning lane at the NE 15 Avenue/NE 13 Street intersection. The intersection improvements include, but are not limited to, site preparation, asphalt pavement installation, pavement marking installation, and signage installation. Green-colored bike lanes are an optional pay item.

On June 24, 2025, the City, via the Procurement Services Division, issued Invitation to Bid (ITB) Event No. 495-1 – NE 15 Avenue at NE 13 Street Intersection Improvement seeking bids from qualified contractors to provide construction services for the City's 10/23/2025

Transportation and Mobility Department.

Addendum No. 1 was issued on July 23, 2025, to extend the bid opening by one (1) week to allow additional time and encourage broader bidder participation.

The City received four (4) bids from the following firms, which opened on July 30, 2025:

- 1. M & M Asphalt Maintenance, Inc. (All County Paving)
- 2. Heavy Civil, Inc.
- 3. Florida Blacktop, Inc.
- 4. MEI Construction, LLC

Staff reviewed the four (4) bids for compliance with the solicitation requirements. All County Paving was deemed the lowest, responsive, and responsible bidder and is recommended for award.
