TITLE:	Motion Authorizing the City Manager to Execute a Five-Year Extension and Any Remaining Extensions to the Lease Agreement with Broward County for Parking Lot I at South New River Drive East and Southeast First Avenue – (Commission District 4)

### **Recommendation**

Staff recommends that the City Commission approve a five-year extension and any remaining extensions to the lease agreement with Broward County for the public Parking Lot I, located at the corner of South New River Drive East and Southeast First Avenue, and authorize the City Manager to execute the five-year extension and any remaining extensions under this agreement, in substantially the form attached.

### **Background**

On December 7, 2004, the City Commission approved an agreement with the Broward County for the lease of the property located at the southeast corner of South New River Drive East and Southeast First Avenue, which is used as a public parking lot. While the initial term of the agreement was for five (5) years, the agreement provides the option for the City to, subject to the County's approval, renew lease for five (5) additional five (5) year periods upon the same terms and conditions as in the original agreement.

The current extended term of agreement expires on March 14, 2025, and if approved, the agreement would be extended through March 14, 2030.

Additionally, the administration seeks the authorization from the City Commission for the City Manager to execute any remaining extensions under this agreement in the future (for period between March 15, 2030, and March 14, 2035).

Pursuant to the agreement, the City will continue to pay to the County, an amount equal to fifty percent (50%) of the monthly gross parking meter revenue derived by City from the use of the metered spaces located on the property.

The parking lot includes forty-five (45) spaces, including two (2) spaces for people with disabilities.

## Resource Impact

There is an anticipated positive fiscal impact to the Parking Fund in the amount of \$61,214 for the remaining six months of FY 2025. Staff anticipate a positive annual impact in the amount of \$122,248 in future fiscal years.
