RESOLUTION NO. 20-135

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING THE SIXTH AMENDMENT TO THE INTERLOCAL AGREEMENT WITH THE LAUDERDALE TRANSPORTATION DOWNTOWN FORT MANAGEMENT ASSOCIATION, INC. FOR COMMUNITY BUS AND TRANSIT SERVICES TO ELIMINATE FARES FOR THE BEACH LINK AND LAS OLAS LINK ROUTES. REMOVE ADVERTISING ON VEHICLES USED FOR PROVIDING SERVICE, SPECIFIC LOCATIONS DESIGNATE FOR COMMUNITY SERVICE STOPS. AND SHUTTLE TO EXTEND INTERLOCAL AGREEMENT ON A MONTH-TO-MONTH BASIS, TO NO LATER THAN JUNE 30, 2021, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SIXTH AMENDMENT, **PROVIDING** FOR CONFLICTS, **PROVIDING** FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Fort Lauderdale, Florida (the "City") and the Downtown Fort Lauderdale Transportation Management Association, Inc. ("TMA") entered into an Interlocal Agreement ("ILA") for the TMA to operate the City community bus and transit services; and

WHEREAS, the initial term of the ILA was from October 1, 2014 through and including September 30, 2017; and

WHEREAS, on April 20, 2015, the parties entered into a First Amendment to the Interlocal Agreement that added the Uptown Link transit route to the community bus services provided by TMA; and

WHEREAS, in 2017, the ILA was extended for one (1) year; and

WHEREAS, on October 9, 2018, the parties entered into a Second Amendment to the ILA that extended the term of the ILA until September 30, 2019 and amended the approval process for changes to the scope of services; and

WHEREAS, on September 16, 2019, the parties entered into a Third Amendment to the ILA to extend the agreement for six (6) months up to and including March 30, 2020 and to modify Exhibits "A" and "E" of the ILA; and

WHEREAS, on December 5, 2019, the parties entered into a Fourth Amendment to the ILA to modify Exhibit "A" of the ILA, to include the new Seabreeze Tram Service; and

WHEREAS, on March 31, 2020, the parties entered into a Fifth Amendment to the Interlocal Agreement to extend the ILA on a month to month basis, not to exceed six months; and

WHEREAS, the parties wish to enter into a Sixth Amendment to the Interlocal Agreement to eliminate fares for the Beach Link and Las Olas Link routes, remove advertising on vehicles used for providing the service, designate specific locations for Community Shuttle Service stops, and to extend the ILA on a month-to-month basis, to no later than June 30, 2021;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct, and are incorporated herein by this reference.

SECTION 2. The City Commission hereby approves the Sixth Amendment to the Interlocal Agreement with Downtown Fort Lauderdale Transportation Management Association, Inc. to eliminate fares for the Beach Link and Las Olas Link routes, remove advertising on vehicles used in providing the service, designate specific locations for Community Shuttle Service stops, and to extend the ILA on a month-to-month basis, to no later than June 30, 2021, and the City Manager is hereby authorized to execute the Sixth Amendment. The City Manager shall notify the Downtown Fort Lauderdale Transportation Management Association, Inc. in writing at least thirty (30) days prior to termination of the agreement.

<u>SECTION 3</u>. That all resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

<u>SECTION 4</u>. That if any clause, section, or other part of this resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this resolution shall not be affected thereby, but shall remain in full force and effect.

<u>SECTION 5</u>. That this Resolution shall be in full force and effect upon final passage and adoption.
