Porter Riverview Ballroom - 201 SW 5th Avenue, Fort Lauderdale, Florida 33312, on Tuesday, June 16, 2026, at 6:00 p.m. or soon thereafter. This Notice will commence the City of Fort Lauderdale's 30-day public comment period beginning on Friday, May 8, 2026, and ending on Thursday, June 11, 2026.

The City of Fort Lauderdale will submit its 2026-2027 Annual Action Plan with list of projects funded with 2026 Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), and Housing Opportunities for People with AIDS (HOPWA) program allocations to the Department of Housing and Urban Development (HUD) on or before August 15, 2026. The City's 2026-2027 allocations are as follows:

CDBG \$1,561,741.00
HOME \$639,713.93
HOPWA \$8,316,890.00

The Draft Action Plan represents HUD 2026-2027 funding year which will be the City's 2027 Fiscal Year
