TITLE:	Motion to Approve Contract for Asphalt Resurfacing at Bayview Drive – M & M Asphalt Maintenance Inc \$980,455

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, with M & M Asphalt Maintenance Inc. for asphalt resurfacing at Bayview Drive in the amount of \$980,455.

Background

This project is located on Bayview Drive between Sunrise Boulevard and Commercial Boulevard. It will implement the vision plan to create a connected community providing multimodal connections for all users in accordance with the Coral Ridge Mobility Master Plan. The work to be accomplished under this contract includes milling and resurfacing; thermoplastic striping of two ten-feet driving lanes, four-foot wide bicycle lanes on both sides with bicycle symbols and arrows; and other items quantified in the solicitation.

On July 11, 2017, the Commission rejected a motion to approve a change order to the annual Asphalt Resurfacing Contract for this work and directed staff to procure work as a stand-alone contract (CAM 17-0850).

On September 17, 2017, the Procurement Services Division issued Invitation to Bid Number 12042-173. Four bids were received on November 2, 2017. All bids were reviewed for compliance with the solicitation specifications. The bid submitted by M & M Asphalt Maintenance, Inc. has been deemed lowest cost, responsive, and responsible and is recommended for award.

Resource Impact

There will be a fiscal impact to the City in the amount of \$980,455 for the construction contract and \$98,000 for estimated in-house project fees or a total of \$1,078,455. Funds for this purchase are available in the FY 2018 Community Investment Plan in the accounts listed below.
