- FS 403.415 "Florida Motor Vehicle Noise Prevention and Control Act of 1974"
- Intent of FS 403.415 is to implement the state constitutional mandate of s. 7, Art. Il of the State Constitution to improve the quality of life in the state by limiting the noise or new motor vehicles sold in the state and the noise of motor vehicles used on the highways of the state.

• Enactment of local ordinances limited unless expressly authorized.

- FS 316.3045 Operation of radios or other mechanical or electronic soundmaking devices or instruments in vehicles
  - (1) A person operating or occupying a motor vehicle on a street or highway may not operate or amplify the sound produced by a radio, tape player, compact disk player, etc., which sound emanates from the motor vehicle, so that the sound is:

(a) plainly audible at a distance of25 feet or more from the motorvehicle; or


(b) louder than necessary for the convenient hearing by person inside the vehicle in areas adjoining private residences, churches, schools, or hospitals.

#### • FS 316.3045, continued

(4) This section does not prohibit a local authority from lawfully imposing stringent more regulations sound on produced by a radio or other mechanical electronic or soundmaking device or instrument as described in (1), which sound subsection emanates from a motor vehicle.

## Fort Lauderdale Vehicle Noise Restrictions

- Section 17-7
  - (1) Amplified sound No person shall cause, allow, or permit the operation of any amplified sound device from the following use districts or locations in the following manner:

(b) Rights-of-way. Sound shall not be plainly audible at a distance of twentyfive (25) feet or more from a motor vehicle or any other sound source.

• Section 17-7

9. Motor vehicles, motorcycles, mopeds and motorized scooters. No person shall cause a rapid throttle advance (revving) or any internal combustion engine resulting in a noise disturbance.
