TITLE: Motion to Work Order No. 7 in the amount of \$170,425.75 with Weekley Asphalt Paving, Inc., under the Annual Asphaltic Concrete Pavement Contract – Project 11945 – Lauderdale Memorial Park Cemetery

Recommendation

It is recommended that the City Commission approve Work Order No. 7 with Weekley Asphalt Paving, Inc. in the amount of \$170,425.75 plus \$14,074.25 for administration and engineering fees under the Annual Asphaltic Concrete Pavement Contract, contingent upon approval of the consolidated budget amendment, CAM 14-0090.

Background

This project consists of a 1-inch asphalt pavement overlay on an existing asphalt surface for the streets and parking lot within Lauderdale Memorial Park Cemetery, located at the northwest corner of State Road 84 and SW 4th Avenue. Weekley Asphalt has prior City experience and has performed well on other City paving projects. This project will upgrade the pavement integrity, pavement markings and overall look of the property.

On September 3, 2013, the City Commission approved a one-year contract in an amount not to exceed of \$2,133,738 with Weekley Asphalt Paving, Inc. for street resurfacing. On January 9, 2014 the Cemetery System Board of Trustees approved the paving of the Lauderdale Memorial Park Cemetery using the City's Annual resurfacing Contract.

In compliance with Section 2-179(5) of the City Code of Ordinances, all work orders under an annual contract in a cumulative amount over \$25,000.00 must be brought back to the City Commission for review and approval.

Resource Impact

There is a fiscal impact to the City in the amount of \$184,500.00. This amount includes \$170,425.75 for the Work Order and \$14,074.25 for associated engineering fees. Funding for this item is contingent upon approval of the consolidated budget

amendment, CAM 14-0090.
