TITLE: Grant Agreement with Broward County for Fifteen (15) Mass Casualty
Incident (MCI)/Active Shooter Bags

Recommendation

It is recommended that the City Commission authorize the City Manager to accept equipment from the Town of Davie via the Broward County Office of Medical Examiner and to execute any documents required to accept fifteen (15) mass casualty incident/active shooter bags.

Background

The State of Florida, Department of Health, Bureau of Emergency Medical Services through Broward County Office of Medical Examiner & Trauma Services has sub-granted the FY 2015 Broward County Emergency Medical Services (EMS) Grant Program to the Town of Davie to provide funds to address EMS equipment, training and other needs.

In accordance with the Broward County FY 2015 EMS Grant Program, the City of Fort Lauderdale was added to a resolution in the Town of Davie and Broward County and will uphold the Memoranda of Agreement (MOA) which identifies the distribution of equipment by the Town of Davie which specifies maintenance and inventory responsibilities in accordance with Broward County EMS Grant Program policies.

The MCI/Active Shooter backpack(s) enables paramedics to treat and prepare for the transfer of up to 14 victims. Included in the backpack is two (2) fanny packs and a total of fourteen (14) each (tourniquets, hemostatic dressing, chest seals and chest decompression needles), patient mover and MCI/active shooter paperwork.

The City of Fort Lauderdale will accept the following items:

Fifteen (15) – Mass Casualty Incident (MCI)/Active Shooter bags @ \$1,453/each = \$21,795
