TITLE: Motion Approving Purchase of Fence, Chain Link and Picket – Tropic

Fence, Inc.- \$1,252,675 - (Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve a one-year agreement, in substantially the form attached, for the purchase of fence, chain link and picket materials, from Tropic Fence, Inc. in the estimated annual amount of \$1,252,675 and authorize the City Manager to approve three (3), one-year renewal options, contingent upon appropriation of funds.

Background

The Parks and Recreation Department maintains various types of fences for numerous City parks and facilities. Repairs and installation of new fencing materials are frequently needed. Specific line items, based upon line-item pricing, will be used as they relate to the required repairs throughout the contract term. Several other departments also have installation and repair needs and their estimated quantities are included in the bid tabulation.

The Procurement Services Division issued Invitation to Bid No. 12493-512 and received two bids. The bid submitted by Tropic Fence, Inc. has met all the specifications of the bid and has been deemed the lowest cost, responsive and responsible bidder. Both bidders have indicated their status as a Minority Business Enterprise, Women Business Enterprise or Small Business Enterprise.
